	<p>In 2014, an EC has been issued and the same was amended in 2015. Now, the PropONENT, M/s. Renuka Business Holding & development Pvt. Ltd has applied for Environmental Clearance for the proposed Modified construction project in the form of Residential Building complex with a built up area of 95,380 Sq.m at S.F.No. 508/15C1, 508/15C2, 508/16A2, 508/16B, 508/23B, 508/24, 508/25A, 508/25B, 508/29, 508/30A, 508/30B, 508/31, 508/13B2B, 508/13B2C, 508/17, 508/18, 508/19B1, 508/19B2, 508/19C, 508/19D, 508/19E, 508/20A2, 508/20B, 508/20C, 508/26A, 508/26B, 508/32A, 508/32B, 508/33A, 508/33B, 508/34A1, 508/34A2, 508/34B, 508/35B & 512/8B, Sholinganallur village, Sholinganallur Taluk, Kanchipuram District, Tamilnadu on 10.10.2017.</p> <p>Because of the modifications, the builtup area now will be 95380 sq.m instead of 92303 sq.m before modification. Water supply will increase from 269 KLD to 270 KLD. There are a few changes in blocks in terms of stilt, basement, etc.</p>




Minutes of the 99th SEAC Meeting held on 11th December 2017

The proposal was placed in the 99th meeting held on 11.12.2017. Based on the presentation made by the proponent and the documents furnished, the SEAC decided to recommend the proposal for grant of EC to SEIAA subject to usual condition after obtaining the following details:

1. The proponent should submit detailed plan for green belt development for an area of 6870 sq.m to accommodate 275 trees.
2. The proponent has to submit an affidavit to the effect that land under survey number. 512/8b has been handed over to the Corporation of Chennai as part of the OSR land.
3. The storm water drain should be appropriately designed and constructed to take excess storm water to the Sri Raman Eri. The proponent should ensure that the Sri Raman Eri should not be polluted by the project activity.
4. An amount of Rs. 122 Lakhs shall be spent for infrastructure development activities for nearby government schools for education and sports facilities as a part of CSR before the completion of the project.
