### **Minutes of the 705<sup>th</sup> Meeting of the State Level Environment Impact Assessment Authority, UP (SEIAA) held on 15.03.2023**

The meeting of 705<sup>th</sup> State Level Environment Impact Assessment Authority, UP (SEIAA) was held on-line on 15.03.2023 the Directorate of Environment. The following were present in the meeting:-

Chairman SEIAA did not participate in the meeting. 705<sup>th</sup> State Level Environment Impact Assessment Authority, UP (SEIAA) meeting was convened and conducted in reference to the letter no. 135/81-7-2023-103(parya)/2007 dated 7-2-2023 of Department of Environment Forest and Climate Change, GoUP.

1. **"Ordinary Soil Excavation" Project at Gata No.- 77, 76/1, 76/2, 199Mi, 202Mi, 203Mi, 204Mi, 228Mi, in the Village-Baripur, Tehsil & District- Moradabad, Shri Naeem Ahmad. File No. 7303/Proposal No. SIA/UP/MIN/404376/2022 Area (in Ha.) - 1.205 Ha.**

SEIAA noted that the above project was taken in its 679<sup>th</sup> meeting in which SEIAA opined that the project proponent shall submit notarized legible copy of agreement between all the land owners and lease holder and NOC from bank for land mortgaged in bank. The project proponent has submitted his reply vide letter dated 22.12.2022. In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022. SEIAA opined to accept the recommendation of SEAC-1 and grant EC to the said project along with all the general and specific conditions as suggested by SEAC but SEIAA replaces the specific condition regarding cluster certificate as "If in future during the progressive mining this lease area becomes part of cluster i.e. area equal to or more than 5 ha., limited to B-1 category, then additional conditions based on the EIA conducted by the concerned lease holders shall be imposed and joint EMP shall be implemented. The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. If the certificate related to cluster provided by the competent authority is found false or incorrect then punitive actions as per the law shall



be initiated against the authority issuing the cluster certificate" and adding following conditions:-

1. Validity period of this EC is 3 months from the date of issue as the LoI has been issued for a period of 3 months or co-terminus with the validity of current mine plan or current lease period whichever is earlier. After this period the EC will become null and void.
2. A certificate from Forest Department shall be obtained that no forest land is involved in mining or as a route and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Forest (conservation) Act, 1980 and submit before the start of work.
3. The mining lease holders shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora fauna etc.
4. If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.
5. Project Proponent should submit action plan for carrying out plantation at least @1,000 plants / ha of lease area. In this case, PP should prepare a plan, duly approved either by Forest Department or Horticulture Department, for planting at least 2,000 plants, either on government land or community land, within a periphery of 5 km from the boundary of the lease area along with provision for maintenance for 5 years. Survival of plants should not be less than the survival rate notified by Uttar Pradesh Forest Department otherwise it will be treated as violation of EC condition.
6. In consultation with District Environment Authority or an Authority nominated by concerned DM, project proponent will prepared a conservation and management plan for rejuvenation and management of water bodies having total surface area of more than 10-ha. Funds for the same will be kept in a separate bank account and six monthly compliance status will be presented by project proponent before the nominated authority in the District.
7. Department of Geology and Mines, Government of Uttar Pradesh and / or concerned district administration, before releasing the security deposit to Project Proponent will ensure that Project Proponent has fully complied with the EC conditions. Non-compliance, if any, should be reported to UPSPCB for appropriate legal action and recovery of compensation.
8. Any application for transfer of this EC, during its validity period unless it is cancelled by a competent authority, has to be necessarily accompanied with status of compliance of EC conditions duly certified by IRO, MoEFCC, GoI, Lucknow.
9. If the air quality deteriorates due to mining, then District Administration & Directorate of Mining should ensure that mining be stopped immediately. Adequate measures be taken for restoring air quality and mining should commence only when air quality attains the prescribed standards.

SEIAA noted that the above project was taken in its 680<sup>th</sup> meeting in which SEIAA opined that the project proponent shall submit notarized legible copy of agreement between all the land owners and lease holder and NOC from bank for land mortgaged in bank. The project proponent has submitted his reply vide letter dated 22.12.2022. In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022. SEIAA opined to accept the recommendation of SEAC-1 and grant EC to the said project along with all the general and specific conditions as suggested by SEAC but SEIAA replaces the specific condition regarding cluster certificate as "If in future during the progressive mining this lease area becomes part of cluster i.e. area equal to or more than 5 ha., limited to B-1 category, then additional conditions based on the EIA conducted by the concerned lease holders shall be imposed and joint EMP shall be implemented. The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. If the certificate related to cluster provided by the competent authority is found false or incorrect then punitive actions as per the law shall be initiated against the authority issuing the cluster certificate" and adding following conditions:-

1. Validity period of this EC is 3 months from the date of issue as the Lol has been issued for a period of 3 months or co-terminus with the validity of current mine plan or current lease period whichever is earlier. After this period the EC will become null and void.
2. SEIAA noted that the above project was taken in its 671<sup>st</sup> meeting in which SEIAA opined that- EC transfer issued vide letter no. 408/parya/ SEIAA/4911/2021 dated 05.01.2022 be kept in abeyance till further order. Refer the case to DM, Banda for enquiry and necessary action. Issue showcase notice to project proponent along with copy of said letter asking them to submit their reply latest by 15.12.2022 clearly explaining as to why EC transferred to them vide letter no. 408/parya/SEIAA/4911/2021 dated 05.01.2022 should not be cancelled. Send a letter to DM, Banda that no mining carried out till the time EC transferred is kept in abeyance. The project proponent M/S Pahlwan traders has submitted his reply vide letter dated 29.12.2022 along with copy of Commissioner, Chitrakoot division dated 07.02.2022. Hence SEIAA agreed to restore EC letter no. 408/parya/SEIAA/4911/2021 dated 05.01.2022 and the EC shall remain valid.

SEIAA noted that the above letter is not addressed nor endorsed to SEIAA, Directorate of Environment hence no action is required.





**5. Institutional Building (IT/ITES Building) Project at Plot No.- B-23, Sector-62, Noida, Uttar Pradesh by M/s Seven Star Infosoft Pvt. Ltd., File No. 6580/ Proposal No. SIA/UP/MIS/229916/2021**

SEIAA noted that the above project was taken in its 601<sup>st</sup> meeting in which SEIAA- found that QCI validity of the consultant is mentioned as 21-12-2021 in the MoM of SEAC-2 while the presentation was made before SEAC-2 on 26-04-2022. The committee went through the reply dated 16/09/2022 submitted by project proponent and observed that due to typographical error in meeting of minutes dated 26/04/2022 the validity of QCI/NABET accreditation for the consultant mentioned as 21/12/2021 instead of 13/06/2022. The committee recommended to grant the environmental clearance for the project proposal along with environmental clearance conditions as earlier stipulated in 647<sup>th</sup> SEAC meeting dated 26/04/2022. In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022. SEIAA opined to accept the recommendation of SEAC-2 and grant EC to the said project along with all the general and specific conditions as suggested by SEAC-2. In addition to the conditions imposed by SEAC, SEIAA added following additional specific conditions:-

- 1- The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
- 2- The project proponent shall ensure to plant broad leaf trees and their maintenance. The CPCB guidelines in this regard shall be followed.
- 3- The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. CER activities must not be less 2% of the project cost. The CER activities should be related to mitigation of Environmental Pollution and awareness for the same.
- 4- The project proponent shall submit within the next 3 months the details of estimated construction waste generated during the construction period and its management plan.
- 5- The project proponent shall submit within the next 3 months the details of segregation plan of MSW.
- 6- The project proponent shall ensure that waste water is properly treated in STP and maximum amount should be reused for gardening flushing system and washing etc. For reuse of water for irrigation sprinkler and drip irrigation system shall be installed and maintained for proper function. Part of the treated sewage, if discharged to sewer line, shall meet the prescribed standards for the discharge.
- 7- Under any circumstances untreated sewage shall not be discharged to municipal sewer line.
- 8- The project proponent will ensure that proper dust control arrangements are made during construction and proper display board is installed at the site to inform the public the steps taken to control air pollution as per the Construction and Demolition



Waste Management Rules.

- 9- The project proponent shall install micro solar power plants, toilets in nearby villages, public place or school from CER fund of the project for which E.C is granted in addition to and water harvesting pits and carbon sequestration parks / designed ecosystems.
- 10- A certificate from Forest Department shall be obtained that no forest land is involved and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Forest (conservation) Act, 1980 and submit before the start of work.
- 11- In compliance to Hon'ble Supreme Court order dated 13/01/2020 in IA no. 158128/2019 and 158129/2019 In Writ petition no. 13029/1985 (MC Mehta Vs GOI and others) anti-smog guns shall be installed to reduce dust during excavation.
- 12- If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.
- 13- Provision for charging of electric vehicles as per the guidelines of GoI / GoUP should be submitted within the next 3 months.
- 14- PP should display EC granted to them on their website. 6-monthly compliance report should be displayed on their website and to be given every six month to residents / occupants of the building.
- 15- EC is granted with the condition that EC is valid only for the building plan which has been submitted by PP for seeking EC. In case approved building plan is different from the one submitted for seeking EC then this EC will stand null and void.

SEIAA opined to accept the recommendation of SEAC-1 and grant EC to the said project along with all the general and specific conditions as suggested by SEAC but SEIAA replaces the specific condition regarding cluster certificate as "If in future during the progressive mining this lease area becomes part of cluster i.e. area equal to or more than 5 ha., limited to B-1 category, then additional conditions based on the EIA conducted by the concerned lease holders shall be imposed and joint EMP shall be implemented. The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. If the certificate related to cluster provided by the competent authority is found false or incorrect
