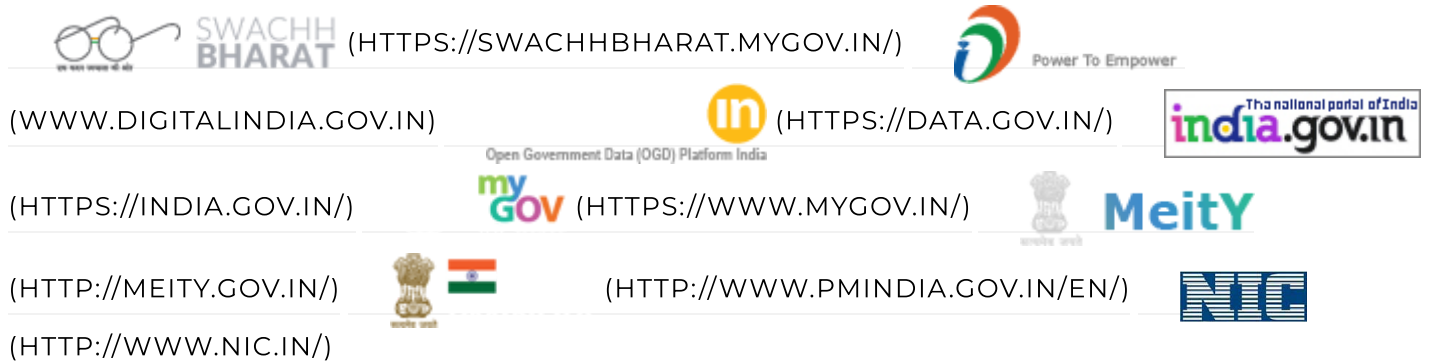
- (ii) Compliance Report from Regional Office, MoEF&CC (Applicable for projects already having EC).
