The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1: The proposal was deferred in the 5.114th meeting of the Authority held on 15.03.2024 till the final outcome of the stay order imposed by the Hon'ble Supreme Court in W.P.(C) no. 1394/2023 titled Vanashakti vs. Union of India dated 02.01.2024. PP vide his representation dated 18.03.2024 had requested an opportunity for personal hearing. PP was heard during the meeting. PP stated that their case is covered under the clarification order issued by the Hon'ble Supreme Court dated 02.02.2024 in I.A. 25309/2024. PP has submitted all valid orders and documents in support of the contention. Detailed order of the Authority is on file. Hence, the Authority decided to refer back this proposal to SEAC for reconsideration of its earlier recommendation in light of the facts stated and for appraisal of the proposal submitted and recommendation.
- 2. Serial No. 2: The proposal was deferred in the 5.118th meeting of the Authority held on 16.04.2024 according an opportunity to the PP to explain the proposal in detail. PP and Consultant were heard during the meeting. On behalf of the PP, it was explained that the industrial area was being developed in two phases, as is the standard practice followed by RIICO. Phase-I of this project being less than 50 Ha. and with no Category A or B industry proposed, did not require prior EC. Hence, the Authority decided to defer this proposal and the PP was directed to submit the required documents to ascertain that the planning, sanction etc. of the industrial area was in two phases, within 45 days.







- 3. Serial No. 3: The proposal was deferred in the 5.119th meeting of the Authority held on 26.04.2024 and PP was called for a presentation to explain the projected population and parking provisions provided in the proposal. PP and Consultant were heard in the meeting. They made a submission that they have increased the parking in accordance with the National Building Code, 2016. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal, subject to increased parking provisions, as revised.
- 4. Serial No. 4: The proposal was deferred in the 5.120th meeting of the Authority held on 30.04.2024 for submission of documents relevant to the arguments made by PP and Consultant in the meeting. PP in his representation, has submitted all the relevant documents asked for. The documents submitted were found satisfactory and in accordance with the queries raised by the Authority. Hence, the Authority decided to accept the recommendations and additional conditions of SEAC and to grant approval of EIA/EMP and EC to this proposal subject to deposition of the Bank Guarantee of Rs. 4,50,000/- towards Remediation Plan and the Natural Resources and Community Resources Augmentation Plans with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project. The PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects
- 5. Serial No. 5, 6, 7, 9: The Authority decided to accept the recommendations of SEAC and decided to close and delist these proposals.
- 6. Serial No. 8: In this proposal, the PP and Consultant in their affidavits submitted with the proposal, have not stated their stance regarding compliance or non-compliance of the Common Cause Judgement of the Hon'ble Supreme Court. Hence, the Authority decided to defer this proposal for submission of affidavits with the mention of compliance or non-compliance of the Common Cause Judgement, within 45 days.
- 7. Serial No. 10, 11, 12, 14, 16, 18, 20, 21, 22, 27, 28, 31, 33, 37: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals.
- 8. Serial No. 13, 26, 36: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals. PPs shall ensure to comply with the conditions imposed in the certificate issued by the Water Resources Department.
- Serial No. 15: The Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal. PP shall

also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects and to comply with the conditions imposed in the certificate issued by the Water Resources Department.

- 10. Serial No. 17: In this proposal, the affidavit submitted is not in the name of PP. Hence, the Authority decided to defer this proposal for submission of affidavit in the name of PP. Along with this, the details of all habitations nearby with the population in each and a clarification in regard to the land details also to be submitted within 45 days.
- 11. Serial No. 19: The Authority decided to refer back this proposal to SEAC for reconsideration of this proposal with following observations:
 - A. Khasra numbers are wrong on Note-sheet and Abstract of the Committee.
 - B. Certificate from DCF Jaipur was not found in the file.
 - C. EC was issued under EIA Notification, 1994 but production has been carried out after the expiry of EC in the duration 2011 to 2022-2023.
 - D. PP neither applied for EC extension nor for re-validation as per the six months window provided in the OM dated 06.04.2018 by the MoEF&CC.
 - E. In the abstract of the Committee, details of production or non-violation have been wrongly mentioned.
 - F. Date of lease validity has been wrongly mentioned in the abstract.
- 12. Serial No. 23, 24, 25, 29, 32, 34, 35, 38: The Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 13. Serial No. 30: The Authority decided to defer this proposal for submission of clarification and relevant documents in regard to following observations, within 45 days
 - A. Affidavit submitted by PP does not mention anything about violation or non-violation of the Common Cause Judgement of the Hon'ble Supreme Court. Also, affidavit submitted by PP is not as per the format.
 - B. Production figures submitted along with the proposal are given till May 2022.
 - C. Khasra numbers mentioned in the proposal are not in consonance with the Khasra numbers given in the report of Patwari/ Tehsildar.
 - D. The Certified Compliance Report submitted, has expired on 07.05.2023.
 - E. Conservation Plan dated 19.03.2024 and its submission receipt has neither been found in file nor online as mentioned in the abstract of the Committee.





- 14. Serial No. 39, 40, 42, 43, 44, 45, 46, 47, 48, 49, 51, 52, 53: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2024 issued by MoEF&CC.
- 15. Serial No. 41: The Authority decided to grant Transfer EC to this proposal.
- 16. Serial No. 50: The Authority decided to grant Transfer EC to this proposal with the condition that the PPs concerned shall apply for TOR under violation and Reappraisal within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
