





The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1: Proposal was deferred in 5.84th meeting of SEIAA for calling the PP for presentation before the Authority to clarify in respect of meeting the water requirements of the proposed township. The PP along with the consultant made the presentation before the Authority. During the presentation, PP clarified about various aspects of the proposal. After hearing the presentation made by PP/consultant, the Authority was not satisfied with the waste water management system proposed based on Root Zone Technology as well as solid waste management system. PP was directed to resubmit the following:
  - a. Proposal for decentralized STPs with appropriate technology and capacity as per norms.
  - A plot earmarked for segregation of solid waste with an undertaking that required equipment for the same shall also be installed.
  - c. An earmarked plot of appropriate size as per norms for dumping of non-biodegradable solid waste.

Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information within 45 days.

- 2. Serial No. 2: Proposal was deferred in 5.81<sup>st</sup> meeting of SEIAA for "Affidavit regarding implementation of Cluster EMP was not submitted". Now, PP has submitted the same. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 3. Serial No. 3: Proposal was deferred in 5.80th meeting of SEIAA for "area is not mentioned correctly in the DCF certificate and there is no mention of Khasra number, reference number, no information regarding the absence of WLS within 10 km periphery." Now, PP has submitted revised DCF certificate dated 22/06/2023. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 4. Serial No. 4: Proposal was deferred in 5.70th meeting of SEIAA for "PP has submitted the latest CCR, it has been brought into notice of the Authority that the PP has not

complied with GC no. 10 & 15 as per the CCR submitted by the PP. Under these circumstances of non-compliance of conditions of EC issued earlier, it would not be possible to accord EC for expansion". Now, PP has submitted the Action Taken Report for the non-compliance of EC conditions. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC (expansion) to this proposal.

- 5. Serial No. 5: Proposal was deferred in 5.81<sup>st</sup> meeting of SEIAA for "General Conditions 10 and 15 are mentioned as not complied in CCR, for which ATR is required". Now, PP has submitted the Action Taken Report for the non-compliance of EC conditions. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to this proposal.
- 6. Serial No. 6: Proposal was deferred in 5.75th meeting of SEIAA for "In this proposal, as per Form I submitted by PP Sukri Nadi and Uikl Nadi is at 0.01 km from the applied area but no WRD certificate has been given". Now, PP has submitted WRD certificate dated 04/07/2023. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 7. Serial No. 7: Proposal was deferred in 5.83rd meeting of SEIAA for "Khasra number given in Aravalli certificate dated 06.01.2020 does not match with that given in the proposal". Now, PP has submitted a revised Aravalli certificate dated 03/05/2023 and mentioned that due to typing mistake Khasra no. 2414/2023 was written as 2014/2023 in the proposal.

PP has also submitted revised Annexure G along with Simankan Report and requested to rectify and consider khasra no. as 2015, 2612/2015, 2017, 2023, 2413/2023, 2414/2023, 2451/2023, 2024, 2031 and 2111 in this proposal. Considering the same, the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

8. Serial No. 8: Proposal was deferred in 5.83<sup>rd</sup> meeting of SEIAA for "In the Aravalli certificate, cluster certificate Khasra 1072 to 1076 are not mentioned". Now PP has submitted revised Aravalli certificate and Cluster certificate with Khasra No. 1031, 1032, 1121, 1122, 1123, 1124, 1125, 1126, 1127, 1128, 1129, 1130, 1131, 1132, 1133, 1063, 1064, 1065, 1066, 1067, 1068, 1069, 1070, 1071, 1072, 1073, 1074, 1075, 1076, 1077, 1040, 1078, 1079, 957, 958, 959, 961, 962, 965, 966, 967, 960, 935, 936 & 1134 and requested to rectify and consider these khasras in this proposal. Considering the







- same, the Authority accepted the recommendations of SEAC and decided to **grant TOR** to this proposal.
- 9. Serial No. 9: Proposal was deferred in 5.83<sup>rd</sup> meeting of SEIAA for "Affidavit regarding implementation of Cluster EMP was not submitted". Now, PP has submitted the same. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 10. Serial No. 10: Proposal was deferred in 5.73<sup>rd</sup> meeting of SEIAA for "DSR submitted for Marble but proposal is for Granite & LOI expired". Now, PP has submitted the correct DSR and Lease sanction order dated 07/07/2023. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 11. Serial No. 11: Proposal was close and delisted in 5.79 meeting of SEIAA. PP has submitted the revised DCF certificate and cluster certificate dated 05/12/2022 and requested to relist the proposal vide letter dated 19/06/2023. It came into the notice that the PP has not submitted the latest Cluster certificate. Hence, the Authority decided to defer the proposal and directed the PP to submit the latest cluster certificate within 45 days.
- 12. Serial No. 12: Proposal was deferred in 5.81<sup>st</sup> meeting of SEIAA for "DSR was submitted for Granite and application is for Quartz & Feldspar and Certified Production figures for FY 2022-2023 are not submitted". Now, PP has submitted correct DSR but not submitted production figures for FY 2022-2023 duly authenticated by the Mining Department. Hence, the Authority decided to defer this proposal for additional information i.e., submission of past production figures duly authenticated by Mining Department, within 45 days.
- 13. Serial No. 13: Proposal was deferred in 5.83rd meeting of SEIAA for "submission of revised Aravalli certificate mentioning correct area". Now PP has submitted the revised Aravalli certificate dated 05/07/2023. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- 14. Serial No. 14: Proposal was deferred in 5.83<sup>rd</sup> meeting of SEIAA for "DSR is not approved". Now, PP has submitted the authenticated DSR. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to grant <u>EC</u> to this proposal.
- 15. Serial No. 15: The Authority has examined the proposal and is of the view that parking provisions in the proposal are inadequate in light of the nature of the accommodation being constructed. Hence, the Authority decided to <u>defer this proposal for personal hearing</u> on the capacity & utilization of the proposed units and adequate parking provisions.
- 16. Serial No. 16: In this proposal, PP has requested to exempt the public hearing but SEAC has recommended grant of TOR with public hearing. However, the Authority considered it appropriate to afford an opportunity to PP to make a presentation why SEAC's recommendations should not be considered. PP should also clarify with justifications for exemption from public hearing based on OMs or notifications, if any, that may apply to the specific situations in the proposal. Hence, the Authority decided to defer this proposal for personal hearing.
- 17. Serial No. 17: In this proposal, following points has come into the notice of the Authority:
  - a. Form IV attached in the proposal file is of some other project.
  - b. Recommendation of SEAC is not mentioned in Abstract.

Hence, the Authority decided to <u>refer back this proposal</u> to SEAC for rectification/clarification on the same.

- 18. Serial No. 18, 20, 21, 33, and 55: The Authority accepted the recommendations of SEAC and decided to <u>close and delist</u> these proposals.
- 19. Serial No. 19: In this proposal, Specific Condition 4, General Condition 10 and 15 of the Certified Compliance Report regarding the conditions given in the earlier issued EC, are mentioned as Not Complied, for which an ATR is required. Hence, the Authority decided to <u>defer this proposal for additional information</u> i.e., submission of ATR for not complied conditions of earlier EC within 45 days.
- 20. Serial No. 22: In this proposal, Production Certificate of some other project (QL 45/1, M/s. Zaheer Ahmed) is enclosed in the file. Hence, the Authority decided to <u>refer back</u> this proposal to SEAC and asked for clarification on the same.
- 21. Serial No. 23, 39, 40, 41, and 45: The Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to these proposals.

22. Serial No. 24: In this proposal, consultant in his affidavit did not clarify whether the project is of violation or not. Also, the PP has mentioned in the proposal that "Plot area (As per JDA Sub-division plan) is 8843.96 sq. mts. whereas Plot Area (as per actual possession) is 7894.41 sq. mts."

Considering these, the Authority decided to <u>defer this proposal for personal</u>
<u>hearing/presentation</u> to clarify actual status in respect of the area for which EC is sought along with the submission of revised affidavit stating the project falls in violation or not.

23. Serial No. 25: The Company has been doing mining operations on the lease land since 1962 up to 2016, when the mining lease was revoked by the Mining Department. The company was required to have obtained EC under the EIA Notification, 1994 and thereafter EIA Notification, 2006.

However, the company continued its mining operation without EC and have only now applied for EC. As recommended by SEAC, TOR may be issued but on account of reasons stated above, the Authority decided to grant **TOR under violation**.

In addition, PP may also submit the DCF certificate stating the distance from the Atbara Forest boundary to the lease boundary. PP may also incorporate details of precautions that shall be taken in respect of habitation/State Highway/pucca village road that are within the lease area boundary and also submit specific WRD certificate in respect of the water bodies within the lease area in accordance with the OM dated 14/02/2022 of MoEF&CC at the time of submission of EC application.

- 24. Serial No. 26, 27, 34, 36, 37, 42, 44, 50, 51: The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 25. Serial No. 28, 29, 48: In these proposals, Affidavit regarding implementation of cluster EMP is not submitted. Hence, the Authority decided to <u>defer these proposals for additional information</u> i.e., submission of affidavit regarding implementation of cluster EMP, within 45 days.
- 26. Serial No. 30: In this proposal, M.L Reference No. 2019100008626 is mentioned on TOR Letter, mining plan, covering letter, presentation, and Annexure G but in Form I, Note Sheet, and SEAC Abstract it is mentioned as 20221000054768. Hence, the Authority decided to <u>refer back</u> this proposal for rectification/clarification.
- 27. Serial No. 31: In this proposal, SEAC abstract has mentioned that "The EC was granted by SEIAA, Rajasthan for mineral Feldspar over an area of 4.09 ha., in favour

of Smt. Radha Devi W/o Shri Hansraj Patel vide letter dated 12.08.2022 under violation of EIA notification 2006 and B.G. was submitted for remediation as well as penalty amount and resolved that SEIAA may ask the PP to submit a penalty of Violation period earlier which was submitted in form of B.G. in the State Board."

Considering the recommendations of SEAC, the Authority was of the view that PP must provide the submission receipt of Penalty and B.G. given by the PP earlier to the RSPCB. And if no penalty was deposited earlier, then the PP is directed to submit the CA-certified turnover figures and incurred cost for calculation of penalty now. Moreover, Statutory Condition no. 1 (26), 4 (1), 5 (3), 10 (3) and General Condition no. 3, 16 are mentioned as NOT COMPLIED in the Certified Compliance Report of the conditions of earlier issued EC, for which an ATR is required. Hence, the Authority decided to defer this proposal for submission of additional information within 45 days.

- 28. Serial No. 32: In this proposal, PP has submitted DSR of sandstone but the proposal is of Quartz & Feldspar and, PP has not submitted the complete Cluster Mining Plan. Hence, the Authority decided to <u>refer back</u> this proposal to SEAC pointing to its lack of proper technical scrutiny.
- 29. Serial No. 35: In this proposal, DCF, Churu has issued two certificates vide letter dated 19/10/2022 and 13/01/2023 with two different distances for the nearest forest from the lease boundary i.e., 40 m and 52 m, respectively. The Authority took serious note of this. It is well known that SEIAA has not been approving cases where the lease area is at a distance of less than 50 meters from the nearest forest boundary.

In the present case, how does the distance change from 40 m. to 52 m., i.e., technically just above the 50 m limit. The matter calls for an enquiry and its verification. CCF, Bikaner may be asked to conduct an enquiry in this regard. The certificate of actual distance from the forest boundary shall be verified by the CCF and thereafter submitted.

Hence, the Authority decided to <u>defer</u> this proposal for obtaining enquiry report and certificate duly authenticated by CCF, Bikaner within 45 days.

- 30. Serial No. 38: The Authority accepted the recommendations of SEAC and decided to grant TOR to this proposal with the condition to submit revised Aravalli certificate with all the correct Khasra Numbers, Conservation Plan and Cluster Mining Plan at the time of Final EC.
- 31. Serial No. 43: In this proposal, there is no clarity in the proposal with respect to the khasra numbers. Hence, the Authority decided to <u>defer this proposal and call PP/Consultant for personal hearing</u> for clarification on Khasra Numbers.

32. Serial No. 46: In this proposal, PP has obtained the EC vide letter dated 09/01/2006 under EIA notification, 1994 as per which validity of EC was only for 5 years but the PP has continued the production even after expiry of validity of EC and did not apply for EC under EIA Notification, 2006 which is a violation under the EIA Notification, 2006.

Moreover, PP and consultant have submitted affidavits stating that this is not a case of violation. The Authority decided to <u>issue a show cause notice against the PP as well as the consultant for submission of false affidavit and directed the PP for clarification why their application for EC should not be rejected and appropriate legal action taken.</u>

33. Serial No. 47: SEAC has recommended the case for close and delist stating that "The Committee observed that clarification submitted regarding ambiguity in Mining Production Assessment sheet and Production Certificate is not convincing as the clarification submitted by PP has not been supported or authenticated by competent authority issuing mining production figures (i.e. Mining Engineer) unequivocally stating that typographically error had occurred while doing Assessment Sheet for the year 2013-2014 and the production figures given in his letter dated 20/03/2023 are correct. The Committee is not convinced with the reply / clarification submitted by PP regarding ambiguity in Mining Production Assessment sheet and Production Certificate as the same not been supported or authenticated by Mining Engineer."

The Authority decided to give the PP an opportunity of submitting clarification by Mining Department in respect of the variations in the different production figures for the same years, as pointed out by SEAC. Since, such variation is relevant, the same may be submitted in 45 days, in absence of which the recommendation of SEAC shall be accepted.

- 34. Serial No. 49: In this proposal, production capacity of cluster is 164250 TPA (ROM) but in Cluster Mining Plan total capacity of cluster is mentioned as 115187.5 TPA and, affidavit regarding implementation of cluster EMP is not submitted. Hence, the Authority decided to defer this proposal for submission of clarification from Mining department w.r.t capacity of mineral production capacity as stated in Cluster Mining Plan and capacity approved for the PP as per its Mining Plan, given the variation, and affidavit regarding implementation of cluster EMP within 45 days.
- 35. Serial No. 52: The Authority decided to <u>refer back</u> this proposal to SEAC pointing out the following inadequacies in its examination:
  - In CCR, General condition 10 is mentioned as NOT COMPLIED

- PP submitted an affidavit stating that this is not a case of violation but also submitted Remediation Plan and CA certificates. Moreover, in SEAC abstract, it is mentioned that the PP has submitted an affidavit stating "there is a violation of EIA Notification".
- · Consultant affidavit is not as per the format.
- · Mining Plan is valid till 2022-2023.
- CTO not valid and production was also carried out even after expiry of CTO validity i.e., Feb 2022.
- Production certificate for 2022-2023 not submitted.
- Penalty given by SEAC is Rs 134583.05/- considering Turnover: 1833220/-; Investment: 1.30 Crore. But as per CA certificates, turnover is NIL for violation period i.e., 2014-2017 and investment is 130.02 Lacs. As per calculation penalty is of Rs. 1,30,000/-
- On page no. 245 of EIA report, damage analysis has been done for 2015-16 to 2016-17 but SEAC has considered violation for 2014-15, 2015-16 and 2016-17.
- 36. Serial No. 53: SEAC has recommended to approve EIA/EMP and grant EC to this proposal along with bank guarantee of Rs. 5,80,000/- for remediation plan, natural resource augmentation plan & community augmentation plan and a penalty of Rs. 239146/-.

The Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that condition that the PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 239146/- by online/Demand Draft mode and also submit the Bank Guarantee of Rs. 5,80,000/-towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

37. Serial No. 54: SEAC has recommended the case for close and delist stating that "The PP informed that the mining lease no 85/2013, 86/2013 and 99/2013 are non-operational till date. The Committee further observed that in terms of notification of 01.07.2016 of MoEF& CC the cluster certificate and cluster mining plan are ambiguous as same comprises of 05 mining leases including 03 non-operational mining leases. The Committee further observed that EIA/EMP has been conducted for 22.0031 Hectare cluster area including 03 nos. of non-operational mines. The PP has already been provided sufficient time for clarification /rectification and the PP has failed to submit satisfactory reply against the query raised."

- The Authority decided to defer this proposal and ask PP to submit certificate from Mining Department regarding 3 closed mining leases, otherwise to give the current status of the other 3 leases if they are in operation, within 30 days.
- 38. Serial No. 56, 57: The Authority decided to grant Transfer EC to these proposals.
- 39. Serial No. 58, 59, 60, 61: The Authority decided to grant Transfer EC with the condition that the PPs concerned shall apply for TOR under violation within 45 days. In addition to this RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 40. Serial No. 62, 63, 64: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
