	The proposed project falls under Item No. 1(a) of the schedule of the EIA Notification 2006 and its amendments thereof - (i). Mining of minerals (\leq 250 ha of mining lease area in respect of non-coal mine lease).
	The representative of the project proponent and their consultant B S Enviro Tec Pvt Ltd., have attended the meeting and presented their proposal. The SEAC committee observed that:
	1. The project proponent has obtained violation TOR with public hearing on 24.01.2019 and also obtained TOR extension on 23.08.2022. The Public hearing was held on 21.12. 2022.
	 The issue was appraised in the 213^{thth} SEAC meeting and the decision of SEAC is as follows:
	"The Committee after examining the project proposals, presentations, MoEF&CC Notifications & OMs and detailed deliberations, EIA report and PH minutes recommended to raise ADS for submission of revised water and soil quality analysis reports".
	3. Accordingly, the project proponent has submitted revised water and soil quality analysis reports on 21.04.2023. Hence, this proposal was placed in 221st SEAC meeting.
	 4. The base line data was collected from October, 2021 to December,2021 and the predominant wind direction is observed to be South West to North East. The maximum concentration of SPM is observed to be 61.2 μg/m3. The incremental concentration is 3.08 μg/m3 and GLC of SPM will fall within in mine lease area.


