The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1, 5, 8, 9, 11, 13, 14, 15, 18, 22, 23, 26, 30, 32: The Authority accepted the recommendations and additional conditions of SEAC and decided to <u>grant EC</u> to these proposals.
- Serial No. 2: The Authority accepted the recommendations and additional conditions

Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information i.e., submission of Production Certificate for FY 2023-2024 and receipt of Conservation Plan along with ATR for condition no. 15 of Certified Compliance Report within 45 days.
- 10. Serial No. 19: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC without Violation to this proposal.

- 19. Serial No. 34: In this proposal, the lease was transferred to PP on 31.01.2019. The PP has not applied for transfer of EC in compliance with the OM dated 03.11.2023 issued by MoEF&CC.Hence, the Authority decided to <u>defer</u> this proposal with the direction that the RSPCB shall initiate action against the Project Proponent for non-compliance of O.M. dated 03.11.2023 issued by MoEF&CC. Also, the PP is directed to apply for Transfer of EC, within 30 days.

- 20. Serial No. 35, 41: In these proposals, the lease was transferred in the name of PP on 03.07.2023 and 29.08.2023 respectively and PP has submitted for application for Transfer of EC witin 12 months from the date of lease transfer which is in compliance of O.M Dated 03.11.2023 issued by MoEF&CC. Hence, the Authority accepted the recommendations and additional conditions of SEAC and Grant EC to this proposal.
- 21. Serial No. 51: This proposal pertains to <u>re-appraisal of EC</u> issued by the erstwhile DEIAAs. The Authority accepted the recommendations of EC and decided to <u>grant EC</u> to this proposal with the additional condition imposed by SEAC that the PP shall abide by the final outcome of Hon'ble Supreme Court in WP (C) no. 1394/2023 and/ or any further OM issued by the MoEF & CC and to comply accordingly.
