

- Adopt Green Building Concepts, use renewable energy by adopting Energy Conservation Practices, Energy efficient practices & energy audit practices, etc., and adopt Energy Conservation Building Code.
- Develop green area with tall growing tree species.
- Make provision for Solar Energy on Roof.
- Sufficient rain water harvesting structures shall be provided.
- Consult the Forest Department to translocate the 27 trees which are existing under the proposed building area, as per norms.
- No construction activity should be taken up within the buffer zone of FTL of Hussain Sagar Lake.


