The Authority after detailed discussion and deliberation decided the following:

1. Serial No. 1: Proposal was deferred in 5.90th meeting of SEIAA for "submission of ATR on non-complied conditions of Certified Compliance Report, Revised DCF certificate and was called for presentation to explain details of waste water treatment, reason for no change in population after the proposed modification and other aspects leading to environmental sensitivity of the proposal."

PP was heard during the meeting and the facts put by the consultant were found satisfactory. Now, PP has submitted ATR and other documents. Hence, the Authority decided to accept the recommendations and additional conditions of SEAC and decided to grant Modification in EC to this proposal.

2. Serial No. 2: Proposal was deferred in 5.90th meeting of SEIAA for "submission of details regarding diversion of forest land and called PP for personal hearing to explain the current status of the lease land as the proposal has been under various litigations in the past."

PP was heard during the meeting and as PP explained that the process of the transfer of Forest area diversion in the name of the PP on account of demise of the earlier lessee is under process. In view of the same, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant TOR under violation** to this proposal.

 - Now, PP has submitted revised cluster certificate and Aravalli certificate with correct reference number. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal.
- Serial No. 6: Proposal was deferred in 5.91st meeting of SEIAA for "submission of valid LOI."
 - Now, PP has submitted lease sanction order vide letter dated 17.07.2023. Hence, the Authority decided to accept the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 7. Serial No. 7: Proposal was deferred in 5.92nd meeting of SEIAA as "PP is required to ascertain the correct ML reference no. 20221000052410 as per LoI which is also recorded in Form 1, DCF certificate, Affidavit and Mining plan. However, there has been a typographical error in recording the ML Reference no. in the Aravali certificate, Cluster certificate and Simankan report. PP is directed to get the typographical error rectified in the above mentioned documents."
 - Now, PP has submitted requisite documents with correct ML reference number. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

 Serial No. 9: Proposal was deferred in 5.92nd meeting of SEIAA for "submission of conservation plan as MHTR is within 10 km periphery of lease area."

Now, PP has submitted the conservation plan. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

12. Serial No. 12: Proposal was deferred in 5.87th meeting of SEIAA for "submission of clarification from mining department w.r.t capacity of mineral production capacity as stated in Cluster Mining Plan and capacity approved for the PP as per its Mining Plan, given the variation, and affidavit regarding implementation of cluster EMP".

Now, PP has submitted affidavit and revised Cluster Mining Plan (22/8/2023) with production capacity- 164250 TPA. Hence, the Authority decided to accept the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.

- 24. Serial No. 36: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal. Also, PP shall adhere to the conditions as laid down in WRD Certificate and DCF Certificate.
