Actions on the recommendations of 7th meeting of the SEAC held on 3rd October, 2020.

1. EC for collection of sand from "MPA No. DBR/16/Buridihing/Gamon/Sand MPA at Kotoha Nagar Area" under Dibrugarh Dvn by Sri Dayananda Borgohain. SEIAA.1360/2020 (*Proposal No. SIA/AS/MIN/143822/2020*)

SEAC Resolution 7/5:

The Project Proposal submitted by Shri Dayananda Borgohain for collection of Sand from MPA.No DBR/16/Buridhing/Gamon/Sand under Dibrugarh division is discussed. The Committee after discussion approved the Project for extraction of 5000 Cu.M of sand for 2(Two) years @ 2500 Cu.M per Year from the Proposed mining site. The P.P is allowed to extract the said quantity of Sand strictly following the terms & condition laid down in the Mining Plan approved by the Geology & Mining Deptt.Assam. In addition to the above the P.P is allowed to operate mining operation 15 mtr away from the high bank of the river to avoid bank erosion.

The DFO Dibrugarh Division is requested to ensure monitoring of the mining operation to avoid occurrence of any irregularities.

SEAC Resolution 7/7:

The committee has gone through the Project Proposal submitted by Sri Ananta Borgohain for extraction of river Bed sand from MPA. No. DBR/15/ Buridihing /Gamon /Sand MPA under Dibrugarh Forest Division. The Committee approved the Project Proposal for issue of E.C with condition that extraction be done in the river bed 50 mtr away from the high bank of the river. Further, all the terms & condition laid down in the Mining Plan approved by the Geology & Mining Deptt. Assam has to be strictly followed during the mining operation.

The DFO, Dibrugarh Division is requested to ensure strict compliance of the restrictions mentioned above to avoid occurrence of irregularities in mining process.

3. EC for river Bed with accumulated Sand for Collection under Silchar Forest division by Sibabrata Sarma. SEIAA.178/2014/pt-I (*Proposal No. SIA/AS.MIN/121585/2019*)

SEAC Resolution 7/8:

The Committee has gone through the Project Proposal and documents subsequently furnished for collection of Sand from Daloo River Minor Mineral Unit (sand) under Cachar Division. After discussion the committee approved to issue EC for Collection of 8750Cu.M of Sand in 2(two) years @ 4375Cu.M per year to the P.P Sri Sibabrata Sarma. The committee approved the Project proposal to extract Sand from the river bed leaving 10 mtrs on both the sides of the river bank to avoid river bank erosion. Further, all the terms & Condition laid down in the Mining Plan approved by the Geology & Mining Deptt. Assam shall have to be strictly followed during the mining operation.

The DFO Cachar Division should ensure regular monitoring of the mining operation to avoid occurrence of irregularities.

The Project Proposal submitted by Zander Brahma for mining of stone, sand gravel and ordinary clay from "Sunbari Stone and Sand Mahal" under Baksa Forest Division, BTR has been discussed. After detail discussion the committee approved the project for extraction of 10,000Cu.M stone, 30,000Cu.M of sand gravel and 15,000Cu.M of ordinary clay within 5(five) years period. Annual extraction target for extraction of is fixed as 2000Cu.M stone, 6000Cu.M of sand Gravel and 3000Cu.M of ordinary Clay respectively. The committee is also opined that the mining area should restrict on the sand bar leaving a distance at least 100mtr from the high bank as river Beki is prone to bank erosion. Further, all the terms & condition laid down in the Mining Plan approved by the Geology & Mining Deptt, Assam should also be strictly followed.

The DFO Baska Division will ensure that the mining operation be done following the conditions discussed above to avoid occurrence of illegalities.

The P.P has to follow all the terms & conditions laid down in Mining Plan approved by the Geology & Mining Deptt, Assam. Further, the proposed mining operation is approved on the condition that the P.P shall not start mining operation before 31st Oct/2020 as adviced by the W.R Deptt, Sivsagar.

The DFO, Sivasagar Division is requested to ensure to monitoring of the mining operation from time to time to avoid any irregularities.

Thus annual target for collection of sand is fixed 2100Cu.M.on the condition that mining be done leaving at least 5mtrs distance from high bank of the river. The P.P should also strictly follow the terms and conditions laid down in the Mining Plan approved by the Geology & Mining Deptt. Assam.

The DFO, Karimganj will ensure monitoring of the mining operation to avoid any irregularities.

SEAC Resolution 7/19:

The project proposal submitted by Sri Swapna Bania Das for extension of the EC is discussed in the meeting. Going through the report and after due discussion the committee approved the project for extension of EC for another 2 (two) years for extraction of sand 3000Cu.M and gravel 5000Cu.M from the proposed mining area.
