PROCEEDINGS OF THE MEETING OF STATE LEVEL EXPERT APPRAISAL COMMITTEE, ODISHA HELD ON 13TH AUGUST, 2019

A. CONSIDERATION OF COUNTRY LIQUOR PROPOSALS:

(I) CONSIDERATION OF REVALIDATION OF ENVIRONMENTAL CLEARANCE OF COUNTRY LIQUOR PROPOSALS (25 Nos):

The committee verified the application furnished in Form-I along with documents and checklist of 25 nos. of country liquor proposals (as per **Annexure – I**) for revalidation of Environmental Clearance. The Committee observed the following:

- a) These 25 nos. of country liquor units were operational units prior to grant of Environmental Clearance.
- b) The Hon'ble National Green Tribunal, Eastern Zone Bench, Kolkata passed an order on 15.12.2016 vide O.A. Case No. 124 of 2015/EZ mandating the country liquor manufacturers to obtain EC from the SEIAA under item no. 5 (g) of the Schedule to the EIA Notification, 2006.
- c) These operational country liquor units had obtained Environmental Clearance from SEIAA, Odisha to regularize the illegal operation.
- d) Para 9 of EIA Notification 14th September, 2006 stipulates that the "Validity of Environmental Clearance" is meant the period from which a prior environmental clearance is granted by the regulatory authority, or may be presumed by the applicant to have been granted under sub paragraph (iv) of paragraph 7 of EIA Notification, 2006, to the start of production operations by the project or activity, or completion of all construction operations in case of construction projects (item 8 of the Schedule), to which the application for prior environmental clearance refers.
- e) In the instant case, all these units were operational units at the time of application for Environmental Clearance. The SEAC while recommending the case for grant of Environmental Clearance to these projects didn't stipulate any condition for validity of Environmental Clearance as these are already operational at that time. However, the SEAC recommended in policy guideline to stipulate a condition that "the proponent shall obtain fresh environmental

clearance if they will shift the unit to other location and / or go for higher production capacity".

After detailed discussion, the SEAC opined that revalidation of Environmental Clearance is not required for these 25 nos. of proposals as they are already operational units. Further, the SEAC opined that fresh Environmental Clearance is also not required for these proposals as they are not shifting the unit to other location and / or go for higher production capacity. The SEAC recommended to return these proposals to SEIAA, Odisha with a request to communicate the proponents as above.

(II) CONSIDERATION OF REVALIDATION OF ENVIRONMENTAL CLEARANCE AS WELL AS CHANGE OF OWNERSHIP OF COUNTRY LIQUOR PROPOSAL (02 Nos.):

The committee verified the application furnished in Form-I along with documents and checklist of 02 nos. of country liquor proposals (as per **Annexure – II**) for revalidation of Environmental Clearance as well as change of ownership. The SEAC opined that revalidation of Environmental Clearance is not required for these 02 nos. of proposals as they are already operational units as pointed out at para (I) above. Further, the SEAC opined that fresh Environmental Clearance is also not required for these proposals as they are not shifting the unit to other location and / or go for higher production capacity. However, the SEAC recommended that the SEIAA, Odisha may consider to exercise the provision of para 11 of EIA Notification, 2006 for "Transferability of Environmental Clearance (EC)" for change of ownership of country liquor proposals.

(III) CONSIDERATION OF EXPANSION IN CAPACITY OF COUNTRY LIQUOR PROPOSALS (10 Nos.):

The committee verified the documents furnished along with checklist of 10 nos. of country liquor proposals. The case-wise proceedings and observations of the committee are detailed in Table as per **Annexure – III**. The recommendations of the committee are as follows:

B. CONSIDERATION OF MINOR MINERAL PROPOSALS (02 Nos.):

- 1. The SEAC in its meeting held on 15.04.2019 had recommended the following:
 - a) The SEIAA, Odisha may consider to seek advice of MoEF&CC, Govt. of India about processing and appraisal of minor mineral proposals in view of order of the Hon'ble NGT, New Delhi dated 13th September, 2018 and whether amendment of EIA Notification will be required for the purpose.

- b) The proposals of minor minerals pending with the SEAC will be returned to SEIAA, Odisha till these proposals are submitted with District Survey Report and a clarification received from MoEF&CC, Govt. of India as per the orders of Hon'ble NGT.
- 2. The SEAC verified from the files, there are 02 minor mineral proposals are pending at the proponent end due to want of information.

After detailed discussion, the SEAC decided to return these 02 nos. of minor mineral proposals (as per Annexure - IV) to SEIAA, Odisha for further action as per the above decision of the SEAC. The SEAC also recommended to delist 04 nos. of proposals as per MoEF&CC, Govt. of India OM No.J-11013/5/2009-IA-II (Part) dated 30th October, 2012.
