The members present declared that there are no conflicts of interest with the projects being considered in this meeting.

The Member Secretary, SEIAA welcomed the Chairman and the Member of SEIAA. After general introductory remarks by the Chairman, SEIAA, the Committee took up items agenda-wise and reviewed the recommendations of State Expert Appraisal Committee (SEAC). After detailed deliberations & discussions on recommendations of the SEAC, the SEIAA recorded their decisions on case to case basis as under.

The SEIAA discussed in detail the recommendations of SEAC, it is noted that the proponent obtained EC vide Order dt.19.07.2017 for mining of road metal and building stone with production capacity of 76,985 m3/annum issued by the DEIAA, Warangal Rural District. The lease was executed on 31.10.2015 for a period of 10 years i.e up to 30.10.2025.

It is proposed to mine 76,985 m3/annum of road metal and building stone and the life of mine is reported as 6 years and EC order is valid for a period of 06 years or expiry date of mine lease period, whichever is earlier.

After considering the facts of the case, the SEAC opined that the re-appraisal of EC may be considered as the validity of EC is valid for a period up to 18.07.2024 (considering life of the mine i.e., 6 years and COVID period of one year).

Accordingly, the application was considered as reappraisal of EC and approved the project for Environmental Clearance for Stone & Metal quarry, subject to submission of bank guarantee of Rs. 1.0 lakh and notarized affidavit (within the due date mentioned for processing the DEIAA cases i.e., before 25.03.2025) along with the following additional conditions:

- 1. The proponent shall implement occupational health & safety to the employees and provide insurance.
- 2. The proponent shall transfer money through online/cheque only for CSR activities.
- 3. The proponent shall maintain the photographic evidence of CSR activities.
- 4. The proponent shall implement waste management plan.
- 5. The proponent shall carry out Ambient air quality monitoring by NABL approved laboratory and submit the reports every quarterly.

6. The proponent shall develop greenbelt along the boundary and approach road.
