MINUTES OF THE 95^{TH} MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY, JHARKHAND HELD ON 14^{TH} , 15^{TH} and 16^{TH} JUNE, 2022.

SEIAA examined the recommendation of SEAC and it was unanimously decided that:
