The Authority after detailed discussion and deliberation decided the following:

- Serial No. 8, 11, 14, 15, 25, 37, 39: The Authority based on the recommendation of SEAC decided to Grant EC to these proposals.
- Serial No. 10, 13, 16, 18, 19, 20, 21, 22, 23, 24, 26, 27, 28, 29, 32: The Authority based
 on the recommendation of SEAC, after detailed discussions and deliberations decided to
 approve EIA/EMP of all these proposals and grant EC with the condition that all the lease

- holders of cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 3. Serial No. 3, 6, 7, 9, 12, 33, 34, 35, 36, 38, 40, 41: The Authority based on the recommendation of SEAC decided to Grant ToR to these proposals. Distance from the forest area has not been certified in DCF certificate. The project proponent must submit the certificate for the same along with the compliance of ToR.
- Serial No. 30: The Authority accepted the recommendation, of SEAC and decided to close & delist this proposal.
- 5. Serial No. 1: This proposal is at a distance of 1.89 km from National Chambal Sanctuary (NCS). The ESZ of NCS is yet to be notified. In such case buffer zone extends to 10 km. from the boundary of the sancturey. The PP has applied to N.B.W.L. Hence the Authority decided to defer this proposal till receipt of the recommendation of NBWL.
- Serial No. 2 & 4: The project proponents have submitted a representation and have requested for personal hearing. Hence the Authority decided to defer these proposals till such time.
- 7. Serial No. 5, 17 & 31: The LoI of these proposals has expired. Hence the Authority decided to defer these proposals with a direction that the project proponents must submit extended LoI letter within 45 days for consideration of the proposal.
- 8. Serial No. 42: The Authority in its 4.68 meeting had accepted the recommendation of SEAC and had sent this proposal to MoEF& CC, Govt of India. The project proponent submitted a representation to SEIAA that as per Notification dated 9th May 2022 of Govt of India, the proposal is to be dealt in SEIAA now. Consequently, a letter was sent to MoEF to send the file back to SEIAA. MoEF& CC replied that the file is not traceable in the Ministry and as per Notification dated 9th May, 2022 the matter of environmental clearance falls under the purview of SEIAA Rajasthan. Accordingly the instant proposal is transferred to SEIAA Rajasthan for necessary action as deemed fit.

Hence the Authority decided to refer this proposal back to SEAC 1 with a direction to project proponent to reconstruct the file and submit it to SEAC 1 for further necessary action.

 Serial No. 43: EC was rejected to this proposal by SEIAA in its 4.66th Meeting held on 25th August 2021 as the applied area was at a distance of less than 50 m from the forest boundary.

Hon'ble NGT Central Zone, Bhopal vide its order dated 17th Februrary 2022 in Appeal No. 66/2021(CZ) & IA No. 02/2022in the instant case has directed that SEIAA may reconsider and dispose off the case according to rule.

Hon'ble NGT Principal Bench New Delhi in similar nature of case in Appeal No. 20/2021 (CZ) Premaram vs SEIAA vide its order dated 13th December 2021 stated that "We do not find any ground to interfere with the impunged order. Mining being hazardous, prohibition against mining is not applicable merely within the forest or close to a national park or wildlife sanctuary but also within reasonable distance from eco sensitive area, including a forest as in the present case. Mere recommendation of the SEAC does not create any indefeasible right nor illegal EC to someone else be a precedent to grant EC to all. Proposal for mining in the present case being for area very close to the forest, decision to maintain buffer between the forest and mining is certainly justified to protection of the environment. No right to do mining close to the forest is shown nor any illegality or impropriety shown in the impugned order.

In view of the above fact that the stand taken by SEIAA, of not granting EC in such cases wherein the lease area is within a distance of 50 m from the forest boundary, has been upheld by Hon'ble NGT, Principal Bench, New Delhi, SEIAA reiterates its earlier decision of not granting EC in all such cases wherein distance from forest area is less than 50m. from the forest boundary.
