### **MINUTES OF THE 85<sup>th</sup> MEETING OF THE STATE EXPERT APPRAISAL COMMITTEE HELD IN CONFERENCE HALL, DEPARTMENT OF ENVIRONMENT, SCIENCE & TECHNOLOGY, SHIMLA, ON 19-20<sup>th</sup> JULY, 2022.**

The 85<sup>th</sup> meeting of State Expert Appraisal Committee for appraisal of the Project proposals received for Environmental Clearance was held on 19-20<sup>th</sup> July, 2022 in the Conference Hall of Department of Environment, Science & Technology, Shimla. #### **ITEM NO. 1: Welcome and introduction of SEAC committee members**

The newly constituted Committee was welcomed by the Secretary (SEAC).

#### **ITEM NO. 2: PPT on EIA Clearance Process, EIA regulations and mandate of committee constituted as per Environment Impact Assessment Notification, 2006**

A power point presentation was made before the SEAC explaining EIA clearance process, EIA regulation and mandate of committee constituted as per EIA Notification 2006.

#### **ITEM NO. 3: Appraisal of case applications and ratification of SEAC meetings and subsequent issuance of minutes, letters of ECs & TORs, extension of ECs, Transfer of ECs, corrigendum's/ amendments to concerned applicants of meetings held after July 12<sup>th</sup>, 2021 till constitution of new SEAC & SEIAA in H.P.**

The Committee was apprised that:

- The term of earlier HPSEIAA & HPSEAC was valid 3 years from the date of constitution i.e. up to dated 12-07-2021 as per notification No. S.O. 3445(E) dated 13.07.2018 issued by MoEF&CC, GoI. The online portal credentials were locked by MoEF&CC
- In view of the notification No. SO 2346 (E) dated 16-06-2021, issued by MoEF&CC, GoI, a request was made to MOEF&CC vide letter no. F. No. SEIAA/ 2008/22-Vol.IV-1169 dated 06-08-2021 for extension of validity for another period of six months and reactivation of the login credentials of HPSEIAA & HPSEAC portal.
- Approval of extension was intimated by MOEF&CC Monitoring Cell vide email monitoring-ec@nic.in on dated 06-08-2021 and subsequently the MoEF&CC also re activated the login credentials of HPSEIAA & HPSEAC till 31-12-2021.

- Keeping in view of the extension from MOEF&CC dated 06-08-2021, the process for reconstitution of SEIAA & SEAC was also deferred by the GoHP and in view of extension accorded by MoEF&CC, and SEIAA/SEAC resumed and started appraising the applications for EC & TOR till 31-01-2022 as per process.
- During the period 12-07-2021 to 06-08-2021 no EC or TOR cases were appraised and the process of appraisal was resumed w.e.f. 6-8-2021 i.e. extension communication from MoEF&CC.
- On and after grant of extension of validity further i.e. after 06-08-2021, meetings of HPSEAC were convened as follows:

- Keeping in view of expiry of extended period of SEAC & SEIAA, the GoHP submitted proposal for re-constitution of SEIAA, Himachal Pradesh to MoEF&CC. In response, a letter was received in the office of Addl. Chief Secretary (Env. S&T) vide F. NO. IA3-1/4/2022-IA.III E-174907 dated 21.03.2022 with certain observations, questioning the period of extension of SEAC& SEIAA after 12-07-2021 and direction to enquire into the matter by Addl. Chief Secretary (EST) to the GoHP.
- After attending to all the observations and enquiring upon in the matter detailed reply was sent to MoEF&CC, GoI by GoHP from the office of the Addl. Chief Secretary, (Env. S&T) on dated 06.04.2022.
- The MoEF&CC, GoI re constituted the SEIAA & SEAC, Himachal Pradesh vide notification S.O. No. 2500 (E) dated 01.06.2022.

- In reference to the reply of GoHP, A letter was also sent by MOEF& CC to the Addl. Chief Secretary (Env. S&T) vide F. No. IA3-1/4/2022-IA.III (E-174907) dated 02.06.2022 from with the observations that:

*"The matter has been examined in the MoEF&CC, Govt. of India, and the competent authority has ratified the functioning of SEIAA/SEAC of Himachal Pradesh during the above mentioned period i.e. after 0608-2021 till 31-01-2022. However, it is hereby directed that the proposals considered by the SEIAA/SEAC for the period from 13/07/2021 to 12/01/2022 shall be referred back to the newly constituted SEIAA/SEAC for Himachal Pradesh vide Notification no. S.O. 2500(E) dated 01.06.2022 for ratification. The action taken report in this regard shall be submitted to the Ministry preferably within 30 days from the date of issue of this letter".*

In view of the observations of the MoEF&CC, GoI, all the agenda items of applications considered by the SEIAA/SEAC after 13/07/2021 were placed before the fresh committee for reappraisal and ratification accordingly by SEAC as to complete procedural obligations.

The SEAC after considering the aforesaid facts the SEAC perused and ratified the minutes of all meetings and case applications considered by the SEIAA/SEAC during the period.

Online proposal for granting EC was submitted on dated 25/08/2021 and accepted by the SEIAA secretariat on dated 17/06/2021 and forwarded to SEAC secretariat.

M/s Shriom Organics Pvt. Ltd. is planning to set up an API facility Unit-II complying with cGMP requirements at Plot Nos. 30 & 109-113, Gondpur Industrial Area, Paonta Sahib, District Sirmour, Himachal Pradesh. As informed the land along with the building at Plot Nos. 30, 109 to 113 were purchased from Bank of Baroda in an E-open auction which was earlier run by Unit-III of M/s Jai Murti Minerals & Chemicals Pvt. Ltd. The proposed industry will be manufacturing API namely Thiocolchicoside with production capacity of 2520 kg/annum.

The Committee deferred the case in view of the fact that project proponent did not appeared before the committee. The Committee decided to ask the proponent to submit online applicant requesting to list the case again for appraisal.

Now, the project proponent vide letter dated 14.10.2021 has requested to list his case for appraisal. Now, SEAC shall appraise the same.

The case was listed before the SEAC in its 83<sup>rd</sup> Meeting. After deliberating on the information submitted and considering the facts placed before the committee, the SEAC decided to list the case in next meeting after compliance of the following additional conditions:

1. The project proponent shall submit essentiality certificate from drug controller/ competent authority. Also a certificate to the fact that whether proposed product relates to COVID-19.
2. The project proponent shall submit clarification from MoEF&CC, GoI regarding inclusion of product under API.

After submission of the compliance the case was listed in 85<sup>th</sup> meeting of SEAC.

The SEAC discussed the matter in light of provisions of Notification no. SO 2859(E) dated 16-07-2021 for relaxation of API units till 31-12-2021 and recommended that the SEIAA may seek prior clarification from MoEF&CC, GoI regarding the appraisal of such API/ bulk drug proposals as to whether the applications received before 31-12-2021 or earlier pending before SEAC are to be appraised at the GoI level or by SEIAA in view of the fact that the date of relaxation was only up to 31-12-2021.

#### 4.2 Sh. Rachin Chaudhary and Sh. Rakesh Mohan, VPO Nauni, Tehsil & District-Solan, H.P.

The proposed project is Extraction of Sand.

Online proposal for granting EC was submitted on dated 20/07/2021 and accepted by the SEIAA secretariat on dated 09/08/2021 and forwarded to SEAC secretariat. The hard copy was submitted by Project proponent on dated 22/03/2021.

The project proponent has submitted form-1, pre-feasibility report, letter from State Geologist regarding letter of Intent dated 10.11.2020, copy of approved mining plan from State Geologist dated 05/11/2020, jamabandi & tatima, joint inspection report dated 06.06.2015, NOC from Gram Panchayat mangarh on dated 06/11/2020, 500 meter distance certificate from State Geologist dated 10.12.2020, affidavit regarding CER activities, base line environmental data of air quality, water



quality and noise levels along with site photographs, list of flora and fauna from DFO Rajgarh Forest Division along with fast growing species.

The case was listed before the SEAC in its 83<sup>rd</sup> Meeting. After deliberating on the information submitted by the project proponent and considering the facts placed before the committee, the SEAC decided to list the case in next meeting after compliance of the following observations:

1. The project proponent shall submit the drone video of site.
2. The project proponent shall mark the proposed mining are with permanent concrete boundary pillars along the boundary.
3. The project proponent shall submit revised KML file matching the revenue map/duly attested original tatima.
4. The project proponent shall submit NOC from Panchayat w.r.t. existing road in the proposed mining site.

After submission of the compliance by the PP the case was listed before the SEAC in its 85<sup>th</sup> Meeting. After deliberating on the information submitted by the project proponent and considering the facts placed before the committee, the SEAC decided to list the case in next meeting after compliance of the following observations:

1. The project proponent shall re-workout the mining proposal in view of the existing road crossing the proposed site.
2. The project proponent shall follow mining guidelines issued by the State Government and submit the plan accordingly.

4.3 Sh. C.K. Baljee, Chairman & Managing Director, H.No. 124, 3<sup>rd</sup> Main Defence Colony, Indira Nagar, Bangalore, Karnataka.

The proposed project is construction of residential apartments consisting of 130 units along with hotel having 35 rooms, nursery school, shops, jogging tracks etc. The project site is on hill and comprises with few shrubs, trees and grasses. The project establishment will require preliminary leveling of site prior to construction. As proposed the maximum care will be taken to avoid removing or cutting major grown trees within the site during the construction activities & if any grown trees are obstructing the proposed design structures, a proper transplantation activity should be considered by employing a landscape contractor or nursery professional without damaging.

Online proposal for granting Environment Clearance was submitted on dated 20/11/2020 and accepted by the SEIAA secretariat on dated 01/12/2020 and forwarded to SEAC secretariat. The hard copy was submitted by the project proponent on dated 17/12/2020.

The case was listed before the SEAC in its 78<sup>th</sup> meeting. It was observed that the person present before the Committee was not an authorized person to present the case as per NABL certificate.

*Therefore it was decided the case will only appraised by the Committee, if the approved consultant from the NABET/ NABL is present in the meeting.*

*The pp has submitted the compliance to the observations made by SEAC.*

*The case was listed before the SEAC in its 79<sup>th</sup> meeting. After deliberating on the information submitted by the project proponent and considering the facts placed before the committee, the SEAC decided that before recommendation of the case for grant of EC, following conditions shall be complied by the project proponent:*

- 1. The project proponent shall submit a certificate from Municipal Corporation Shimla w.r.t. implication of Hon'ble NGT orders w.r.t. 2 ½ story restrictions.*
- 2. The Committee shall also seek opinion of AG office in the instant case beside comments from TCP & MC separately.*

**The project proponent has submitted the documents. The case was again listed before the SEAC in its 80<sup>th</sup> meeting.**

The committee observed that the opinion given by office of Ld. Advocate General does not anywhere indicate or refer to the Hon'ble NGT orders under question except for the question w.r.t. grant of registration, besides the fact that the orders need clear explanations before considering the case for grant of environmental clearance. The Orders of Hon'ble NGT are very exhaustive and the department of Town and Country Planning/ MC Shimla need to have strong environmental beneficial basis to recommend the approval after the issuance of the detailed order by NGT rather than taking an excuse that the demanded fees/ security for grant of license fee etc. have been pre calculated or were not deposited within stipulate period and the fact that maps approved by MC Shimla vide letter dated 14-12-2016 prior to Hon'ble NGT orders was in fact not a final approval in any manner and it was subject to certain terms and conditions which doesn't seem to have been complied with, as no documentary proof was produced or placed on record by the project proponent. Hence, in the prevailing position it does not construe upon by the SEAC to consider the case for grant of EC without ensuring the consideration of environmental sustainability factors on priority. Moreover, the explanations given by various authorities doesn't seem adequate and sufficient in view of Hon'ble NGT order. Therefore, the SEAC felt it necessary and observe that it would not be out of context to recommend the matter to SEIAA to seek or refer the matter to office of registrar Hon'ble NGT for clear opinion in the matter in view of the fact that the proposed project is located within the MC Shimla limits.

Based on above observation after deliberating on the information submitted by the project proponent and considering the facts placed before the Committee, the SEAC decided that meanwhile the project proponent submits its compliance to following conditions the matter be simultaneously referred to SEIAA for necessary directions in view of above observations and thereafter to list the case in next meeting for appraisal:

- 1. The project proponent shall submit all the documents related to compliance to the stipulations/ terms and conditions imposed by MC Shimla.*
- 2. The project proponent shall submit the copy of the land use change order issued by the competent authority for the project.*
- 3. The project proponent shall submit revenue records with clear demarcation of road on tatima and NOC of the competent authority for use of the road in future with clear vehicular load.*
- 4. The project proponent shall submit NOC for availability of water issued by the competent authority i.e. Commissioner, MC, Shimla/ SJPN afresh.*
- 5. The Committee will discuss the opinion of AG Office in its next meeting.*
- 6. The project proponent shall submit the comprehensive muck management plan.*
- 7. The project proponent shall submit the comprehensive drainage plan.*
- 8. The project proponent shall submit assessment report on geo safety, earth safety of the project construction site.*

The matter was considered in the 53<sup>rd</sup> meeting of the SEIAA, Expert Member (TCP & Housing & Building Sector) cum the Vice-Chairman SEAC was also specially invited to attend the meeting of SEIAA and explain the entire position with regard to the earlier conditional approval given by the MC Shimla on dated 14-12-2016. This approval of MC had laid down certain conditions which were very critical and approval of the Director TCP was required before the permission of the MC could become effective, these conditions were not complied with before the order of Hon'ble NGT passed on 16-11-2017 as mentioned by the SEAC in proceedings of 80th meeting. The Environmental Clearance was also pre requisite in 2016 and 2017 for this project and factually the project proponent did not apply for the same during or prior to the Hon'ble NGT order dated 16-11-2017 in the matter of Yogindra Mohan Sengupta Vs. Union of India & Others in OA No. 121 of 2014. The Hon'ble NGT has specifically ordered (Refer Para 112-111) and has given specific directions by restricting the construction of new buildings to 2 storeys plus attic floor and no relaxation is available for commercial, private builder and any such allied buildings. The matter needs to be examined whether any case which was not pending before the SEIAA can be considered for any relaxation under any of the relaxation provisions in the order of the Hon'ble NGT or not.

The SEIAA after deliberating on the information decided to ascertain the clarification from Department of TCP and Ld. AG on above.

Accordingly the matter was referred to the respective offices by SEIAA. As per opinion of Ld. Advocate General, Himachal Pradesh High Court vide letter dated 1-14/2018-44193 dated 27.11.2021, it has been clarified that:

*".....the Learned National Green Tribunal order restricting the number of storeys came towards the end of 2017. The order cannot be applied retrospectively. Apart from that SEAC is supposed to apply its mind independently on the environmental issues uninfluenced by any other consideration. The other aspects are required to be taken care by the authorities who have been assigned that job. My opinion is clear on all the aspects on which it was sought and I am not obligated to render my opinion to SEAC. Every authority is supposed to act within its bounds and that equally applies to all including SEAC...."*

And as per opinion of Director, TCP, Himachal Pradesh vide letter dated HIM/TP/APT/LIC-C.K. Baljee/2015/-4721, Dated: 08.10.2021, it was informed that:

*"With reference to the captioned subject and your office letter under reference, it is apprised that the instant matter of Sh. C.K. Baljee, Chairman & Managing Director for project proposal "Resort & Mountain Homes at Bharari Village", Bharari- Kuffer link road, Shimla at Khasra no. 7 & 8 at village Bharari, Tehsil & District Shimla, has been duly considered and approved by the Competent Authorities i.e. Municipal Corporation, Shimla and Town and Country Planning Department as per opinion rendered by the Ld. Advocate General, Himachal Pradesh w.r.t. the implications of the order of the Hon'ble National Green Tribunal dated 16.11.2017 in the matter of OA No. 121/2014 titled as "Yogendra Mohan Sengupta Vs. Union of India and others."*

*The drawings of the residential project were considered and approved by the Municipal Corporation, Shimla on 14.12.2016 and forwarded to TCP Department for according final approval and issuance of License. After scrutinizing, the case was placed in the 13th meeting of the Committee constituted by the Government for scrutinizing and recommending the cases relating to Apartments/Colonies held on 17.04.2017 under the Chairmanship of Director (TCP) and case was approved by the Committee in principle for issuance of License. (Copy of Proceedings enclosed at Annexure-A).*

*Also, it is pertinent to mention here that the case of the applicant was also placed before the 'High-powered Expert Committee', i.e. the 'Implementation Committee' and the 'Supervisory Committee', constituted in pursuance to the order para 112 (XVII) of the Hon'ble National Green Tribunal dated 16.11.2017. The instant case was placed in 13th Meeting of Implementation Committee held on 09.07.2019 and recommended to the Supervisor Committee. Subsequently, the case was considered and approved by the Supervisory Committee in its 5th Meeting held on 25.07.2019, keeping in view the clarifications issued by State Govt. on 01.02.2018 and 24.10.2019 and the subsequent opinion*

rendered by the Ld. Advocate General, Himachal Pradesh vide letter dated 16.05.2019. Copy of the proceedings of both the meetings of the 'High-powered Expert Committee' and the Opinion rendered by the Ld. Advocate General, Himachal Pradesh are enclosed herewith at Annexure-B & C respectively, for information and further necessary action, please."

On request application from the project proponent, the Committee listed the matter in its 82<sup>nd</sup> meeting and further asked the project proponent to submit the compliance through online portal for further necessary action in the matter. The pp submitted the compliance to SEIAA on dated 12.11.2021.

The case was again listed before the SEAC in its 83<sup>rd</sup> meeting. After deliberating on the information submitted by the project proponent and after detailed deliberation on clarification rendered by the TCP department and Ld. AG. The SEAC appraised the case application and decided to list the case in next meeting after compliance of the following observations:

1. The project proponent shall submit the details of proposed STP with capacity and treatment proposed.
2. The project proponent shall submit detailed muck management plan with contour plans.
3. The project proponent shall submit detailed energy equipment and energy saving plan using green energy concepts.
4. The project proponent shall submit solid waste management disposal plan with quantification.
5. The project proponent shall submit contingent plan for holding the waste water in case failure of STP.
6. The project proponent shall submit complete action plan under EMP and CER with budget estimate.

The case application was again listed before the SEAC in its 85<sup>th</sup> Meeting.

The letter/representation received from Mr. Mudit Dixit 138, Ground floor, Woodstock Floors, Nirvana Country, Sector 50, Gurgaon, 122018 received in this office on dated 18.12.2021 against granting unlawful clearance to proposal no. SIA/HP/MIS/184041/2020, HP SEIAA/2020-781 in relation to project located at khasra number 7 & 8 at village-Bharari, Tehsil-& District-Shimla, Himachal Pradesh. It was observed that the matter had been examined by HP SEIAA Secretariat and same was forwarded to Director, Town and Country Planning Department and the Commissioner, Municipal Commissioner in the month of January, 2022 for point wise comments in annotated form for taking further necessary action in the matter please, the reply was yet to be received. The SEAC also examined another similar representation submitted by Ms. Nidhi Trivedi and observed that the reply from TCP & MC Shimla has yet not been received and the same may be awaited.

After deliberating on the information submitted by the project proponent and considering the facts placed before the committee, the SEAC recommended the case application for consideration of grant of environmental clearance by the SEIAA, subject to fulfillment of conditions annexed at Annexure-II with the following additional conditions:

1. In view of violation and refusal by SPCB to register the case of violation against the unit, the Department of Environment, Science & Technology may take further necessary action in view of case of violation as deemed fit.
2. Meanwhile, executing agency shall undertake restoration work in the project site and shall also submit complete ecological & environment restoration plan for further record and verification.
3. The executing agency shall submit the complete plantation plan in the left out green area preferably of native species (deodar, rhododendron, apricot, etc.), and shall start the plantation activities in ongoing monsoon season.
4. The capital cost under CER, the activities to be specified by DEST, GOHP. The project proponent shall take up the matter with Director (DEST) for this purpose within one month from issuance of this letter.

#### ITEM NO. 6:

##### Directions by Hon'ble High Court:-

- 6.1 Directions by Hon'ble High Court in CWPIL No. 108/2017-Court on its own motion V/s State of H.P. & Prs. CWP No. 2077/2017-Amrik Singh V/s State of H.P. & Ors.-regarding.

This is in reference to the subject cited above. In this regard, the CWP was filed before the Hon'ble High Court to declare the **Mand area** as no mining zone and Hon'ble High court vide interim order dated 13.09.2017 has imposed ban on grant of fresh/renewal of mining lease in Mand Area and thereafter no mining lease has been sanctioned/granted by the Government in the said area. Later on case was listed on 06.03.2019, where it was directed that:

.....Learned Additional Advocate General, on the basis of instructions dated 1<sup>st</sup> March, 2019, received from the Department of Environment, Science & Technology, submits that a Committee has been constituted by the State Government for site inspection of Mand area to see the feasibility of sanctioning of fresh/renewal of mining lease. He further submits that four weeks' time may be granted to enable the above stated Committee to submit the



*report. In the interest of justice, list the matter on 29th April, 2019. Meanwhile, the Deputy Commissioner and Superintendent of Police, Kangra at Dharamshala will ensure that no illegal mining of any nature is allowed to take place.*

In compliance to the the directions of Hon'ble High Court the status report-cum-affidavit by Director-cum-Member Secretary, Himachal Pradesh SEIAA was submitted on 10.01.2019 with main observation that:-

1. *Comprehensive and detailed Specific Survey Report of Mand area (downstream to Shah Nahar Barrage to Tamota village stretch after defining State area) may be prepared by Geological Wing of the Industry Deptt. ....*

The case of Amrik Singh V/s State of H.P. & Ors in CWP No. 2077/2017 was listed before Hon'ble High Court on dated 22.06.2022 (copy enclosed), where Hon'ble High Court dismissed the petition with judgment/observation that:-

*.....as per the General Law, the mining activity including extraction of minerals is a legally recognized activity and therefore, unless and until this activity or part thereof is declared illegal, the same cannot be stalled. Therefore, in such circumstances, there cannot be a complete ban on mining in the Mand area in district Kangra and thus there is no question of it being declared illegal under the Mining Policies of the State.*

Now, this office has received a letter from the office of the Director, Industries stating that in compliance to the order dated 26.04.2022, the District Survey Report of District Kangra has been updated by covering the mineral bearing areas and overviews of mining activities in the district with all the relevant features pertaining to geology and mineral wealth in replenish-able add non-replenish-able areas of rivers, stream and other sources. The mineral potential has been calculated based on field investigations taking in to consideration the geology of the catchment area of the river or streams.

**The SEAC in its 85<sup>th</sup> meeting read and noted that the observations of District Survey Report of District Kangra in compliance to the order dated 26.4.2022 and decided to consider same during appraisal process in future.**

**6.2 Implementation of order dated 08.10.2021 passed by Ld. Commission Municipal Corporation Shimla in case of M/s Nirwana Woods & Hotels Private Limited.**

Representation has been received through e-mail from Dr. Pawan Kumar Banta, regarding implementation of order dated 08.10.2021 passed by Ld. Commission Municipal Corporation Shimla in case of M/s Nirwana Woods & Hotels Private Limited. The letter is copy to this Department, where it has been requested to MC Shimla that the order dated 08.10.2021 passed by Ld. Commissioner, MC Shimla in case of M/s Nirwana Woods & Hotels Pvt. Ltd. may not be implemented during the pendency of the appeal before Ld. Principal Secretary UD, Govt. of H.P. with outcome of various inquiry reports.

**The SEAC perused and noted the request of applicant.**

The project is proposed for extraction/collection of Sand, Stone & Bajri from riverbed of Kundlu khad. The project proponent was granted TOR's by MOEF&CC vide letter no. 11015/29/2017-IA.II (M) dated 18.12.2018. Then after the public hearing was conducted by HP SPCB on 10.10.2019. Later on as per Gazette notification of the Ministry of Environment, Forest & Climate Change dated 14.08.2018, the project was categorized as category "B" project, which falls under the purview of SEAC. Now, the project proponent has submitted the final EIA/EMP report to SEAC for grant of Environment Clearance.

The project proponent has submitted hard copy of application on dated 02.03.2020 which was submitted through online portal on dated 19.02.2020.

Online proposal for granting Environment Clearance was submitted on dated 10/02/2020 and accepted by the SEIAA secretariat on dated 19/02/2020 and forwarded to SEAC secretariat. The SEAC secretariat further accepted the proposal after scrutinizing the hard copy submitted by the project proponent on dated 02.03.2020 for technical appraisal of SEAC.

The project proponent has submitted form-I, final EIA report, TOR's letter issued by MOEF&CC vide letter no. 11015/29/2017-IA.II(M) dated 18.12.2018, letter from Director of Industries regarding provisional renewal of mining lease dated 20.09.2012, extension of letter of Intent from Industry Department dated 21.10.2019, letter from Industry Department regarding 500 meter distance dated 04.11.2019, joint inspection report dated 03.08.2010, the letter from Principal Chief Conservator of Forest, H.P. dated 26.02.2011 regarding obtaining of NOC from Forest Department before diversion of Govt. land for non-forestry use, jamabandi dated 20.01.2020, letter from State Geologist regarding approval of mining plan dated 17.09.2016, NOC from Gram Panchayat Kundlu dated 15.12.2019, affidavit regarding CER activities, the credible action of violation under Environment Act, 1986 was also initiated by SPCB, Himachal Pradesh and a fine of Rs. 40,000 was imposed by the Ld CJM Nalagarh on the project proponent which has been deposited vide Receipt No. 0271824 dated 14/7/2018 in the office of Judicial Magistrate Nalagarh, Solan, HP, base line environmental data of air quality, water quality and noise levels and proceeding of Environmental public hearing conducted on dated 03.06.2013 etc.

The case was listed in 73<sup>rd</sup> meeting of SEAC wherein the SEAC deferred the case in view of the fact that the recommendation of project after public hearing was not received by the HPSEIAA secretariat from the State Government for further consideration of the case for grant of EC.

**The case was listed before the SEAC in its 82<sup>nd</sup> meeting. The project proponent did not appear before the Committee. The case was differed.**

Being category B1 project the TORs' were issued on dated 18/12/18. The public hearing was conducted as per the procedure by district administration and State Pollution Control Board on dated 10/10/2019. The proceedings of the public hearing were recommended by SPCB to the office of

Director, Department of Environment, Science & technology on dated 20/12/2019 which were after scrutiny forwarded to HPSEIAA on dated 17/9/2020.

The case was again listed before the SEAC in its 83<sup>rd</sup> Meeting. After deliberating on the information submitted by the project proponent and considering the facts placed before the committee, the SEAC is of the view that as per certificate for 500 mtrs from State Geologist, the propose mining project is falling in cluster with already permitted mining project of Sh. Bidhi Chand of 89.79 ha, thus cluster area is more than 100 ha. Since mining area after cluster is >100ha it is to be ascertained that whether it is to be treated at par as Category-A.

The project proponent submitted that the mining area of Sh. Bidhi Chand is revised but same is different in the certificate issued from the Mining Department.

After deliberating on the information submitted by the project proponent and considering the facts placed before the committee, the SEAC decided to list the case in next meeting after compliance of the following observations:

- 1. The project proponent shall submit the revised letter of 500 mtrs distance from Mining department.*

The case was listed before the SEAC in its 84<sup>th</sup> meeting after compliance by the project proponent. After deliberating on the information submitted by the project proponent and considering the facts placed before the committee, the SEAC decided to defer the case as per request of project proponent and to list the case in next meeting along with compliance of the following observations:

1. The project proponent shall submit letter from State Geologist clarifying that the mining lease of Sh. Vidhi Chand falling in cluster of 500 mtrs has been reduced to 73 ha as the corrections shown in the documents before the committee.

The Clarification from the State Geologist has been furnished by the Proponent.

The case was listed before the SEAC in its 85<sup>th</sup> Meeting. After deliberating on the information submitted by the project proponent and considering the facts placed before the committee, the SEAC recommended the case application for consideration of grant of environmental clearance by the SEIAA, subject to fulfillment of conditions annexed at Annexure-I with following special condition that:

1. The capital cost under CER, the activities to be specified by DEST, GOHP. The project proponent shall take up the matter with Director (DEST) for this purpose within one month from issuance of this letter.


In addition to above agenda SEAC also deliberated up on the following issues and decided that:

#### **A. Observation Of The Committee On Corporate Environment Responsibility**

The SEAC in its 85<sup>th</sup> meeting deliberated on the conditions imposed/recommended under CER during appraisal process for grant of Environment Clearance in various projects. The Committee was of the view that the concerned department shall recommend/specify the activities to be included under CER. Therefore, it was decided that the SEIAA may take up the matter with Department of Environment, Science & Technology, Himachal Pradesh to specify the various activities which are may be required under CER, the proponents in different areas, so that the Committee is facilitated in recommending the conditions accordingly.

- B. The SEAC discussed the pending issues of sitting fee and recommended that the SEIAA may take up this matter with the State Government for revision of the sitting fee.
- C. The SEAC in order to ensure the qualitative scrutinizing and evaluation of the case applications directed the Secretariat to list only 10 case application in a day and agenda shall be prepared and hosted one week before the convening of the meeting. The appropriate time gap may be given to hold the SEIAA meeting as per the directions of MoEF&CC, GoI and at least 7 days time may be accorded for convening the meeting.
