The Project Proponent has deposited Scrutiny fee of ₹ 2,00,000/- vide DD No. 001438 dated 27.05.2022 (in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021).

#### **Appraisal & Recommendations of SEAC:**

The said case was taken up during 264<sup>th</sup>, 266<sup>th</sup> & 271<sup>st</sup> meetings of SEAC held on 28.03.2023, 28.04.2023 & 30.06.2023 and the Appraisal Committee (SEAC) made recommendations to the Authority for Grant of Environment Clearance (under Violation Category) by calculating and recommending a Penalty of Rs. 11.94 Lakh and Environmental Damage Assessment Cost Rs. 11.54 Lakh (Total Rs. 23.48 Lakh) on the Project Cost of Rs. 220.93 Crore.

#### Findings and Decision of THE AUTHORITY (SEIAA):

The said Proposal was taken up during 162<sup>nd</sup> Meeting of SEIAA held on 19.07.2023.

After having gone through the details and relevant record placed on file, alongwith considering the recommendations of the Appraisal Committee (SEAC), the Authority observed as under:

1. There is a discernable variations in determining the details regarding Project Cost, which is an important benchmark for calculation of Penalty and Environmental Compensation Cost for the violations made by the Project Proponent (under EIA Notification dated 14.09.2006):

2. There is variation & mismatching of the Green Area as per the Original Proposal Green Area @30% i.e. 4803.01 Smqtr of the Total Plot Area i.e. 16010.05 Sqmtr

- have been shown less by 4561.08 Sqfts (423 Sqmtrs) by considering and modifying the original proposal by switching over the Net Plot Area i.e. 14597.06 Sqmtr.
- 3. The Authority deemed it appropriate to point out that Appraisal Committee is required to make clear cut recommendations, by keeping in mind, the observations made by Hon'ble NGT in Appeal No. 02 of 2023 and M.A. No. 28 of 2023.
- 4. Further, the Appraisal Committee is required to look into the ATR on the Non-Compliances report filed by RO, MOEF & CC, GOI, Chandigarh.

In view of the above, case is **Referred Back to SEAC** for <u>de-novo</u> calculations and view by taking the cost of the Project @ Rs. 323.20 Crore and other relevant issue as discussed above.

- 1. Is Green Area of the Project increasing by 95% (nearly) from the existing i.e. 57,700 Sqmtrs to 1,05,218 Sqmtrs, without having any change in the total Plot Area i.e. 191893.533 Sqmtrs (47.418 Acres) as per EC dated 29.08.2017. (Whereas Built up Area is proposed to increase by 8826.641 Smqtr, only)?
- 2. Project Cost submitted by the Project Proponent to the Authority & Haryana State Pollution Control Board, <u>reflects vide range of variations and mismatching.</u> This aspects needs to the verified and considered as per the factual position pertaining to the project details / cost. Because, upon expansion of 8826.641 Sqmtr, Project Cost cannot multiply by 150%?

After perusal of relevant record and details placed on file, alongwith considering the recommendations of the Appraisal Committee (SEAC), the Authority decided to agree with the recommendations of the Appraisal Committee to GRANT ENVIRONMENT CLEARANCE to the Project with the following conditions:

- **1.** The Project shall not carry out any activities in the controlled area, Natural Conservation Zone, Eco-Sensitive Zone, Wildlife Sanctuary, if any.
- **2.** The Project Proponent shall maintain Green Area 20.01 % of the total plot area, which shall not be altered, modified or put to any other use than Green activities meant to conserve, preserve and develop the Environment.
- **3.** Project Proponent shall make efforts for the installation of Solar Power infrastructure for the sake of Environment.
- **4.** In view of the increasing Number of electrical vehicles, Project Proponent is expected to make efforts for the installation of electrical charging points at the Project site.

Accordingly, the case is disposed of.

After having gone through the relevant record and details placed on file, alongwith perusing the recommendations made by the Appraisal Committee (SEAC), the Authority decided to consider the recommendation of the Appraisal Committee with

the modification that Environment Clearance to the Project is GRANTED, <u>initially</u> <u>for "1 METER DEPTH for 1 YEAR"</u> with the conditions that the PP shall strictly adhere to the Sand Mining Guidelines, 2020 issued by MOEF & CC, GOI.

The PP shall submit the scientific grid based/ drone based replenishment study for the project site in the river bed within 1 year, (but after rainy season) after the start of the mining at the project site, for further extension of time period and depth upto 3 meters as per approved mining plan/Replenishment Study Report of the project.

Further, the Authority deemed it appropriate to make it amply clear that all Mining Activities at site shall be carried out strictly in accordance with Terms & Conditions as per the DSR, Approved Mining Plan (Mining material as have been permitted by the Mining Department, Haryana), besides any other condition as may be applicable in terms of maintenance of ground water level and distance parameters. No Mining Activities shall be covered by this Environment Clearance, which falls in the restricted areas and controlled areas.

Further, this Environment Clearance is **GRANTED** by the Authority subject to the condition that no case / litigation is pending before any Court in regard to the <u>LOCATION</u> & <u>OPERATION</u> of the site(s) in question.

Accordingly, the case is disposed of.

# Findings and Decision of THE AUTHORITY (SEIAA):

The said Proposal was taken up during 162<sup>nd</sup> Meeting of SEIAA held on 19.07.2023.

The Authority, after having gone through the details and relevant record placed on file, alongwith considering the recommendations of the Appraisal Committee (SEAC), observed that District Survey Report (DSR), pertains to some other District, instead of Charkhi Dadri, where Mining activities are to be carried out.

Besides this the Authority also observed and examined the proposal pertaining to enhancement of Production Capacity from existing 60,00,000 TPA to 85,00,000 TPA. The Appraisal Committee has recommended the same but without any justification. Whereas, the Authority deemed it appropriate to understand, whether proposed enhancement of production capacity will cause any dent on the Environment and other parameters, upon considering the proposal.

This is due to a recent incident, occurred in District-Bhiwani (Mining Site - Dadam), where many lives were lost and thereafter, it was also found that indiscriminate mining has made serious dents on the Environment / local surroundings by disturbing the eco-system (fauna & flora) and adversely affecting the normal life of the people. Hon'ble NGT also made serious observation and constituted a team of Experts to study and understand the reasons, leading to such unfortunate incident.

Therefore, it is more than imperative and urgent to understand, before considering, such proposals, where production capacity of this magnitude i.e. 60,00,000 TPA to 85,00,000 TPA is proposed to be enhanced, without expressing justification and possible dent on the Environment. The Authority is of the view that Appraisal Committee, while considering such proposals should have sought reasonability and circumstances for considering the proposal of enhancement of this magnitude. Therefore, a response needs to be called from Mines & Geology Department, Haryana in this regard.

Further, the Authority decided to constitute a Sub-committee of the followings:

- 1. Member Secretary, SEIAA (Head of the Sub-committee);
- 2. Member Secretary, SEAC (Member);
- 3. Representative of Member Secretary of HSPCB (Member);
- 4. Mining Officer, Charkhi Dadri (Member);
- 5. Regional Officer of HSPCB of the relevant area (To assist the Sub-committee).

The Sub-committee shall visit the project site and submit a detailed report about the proposal.

In view of the above, the **Authority decided to REFER BACK the case to Appraisal Committee (SEAC)** to re-examine the issues of capacity enhancement. Further, the Appraisal Committee needs to look into the precedents, if any and the circumstances and justification for considering such proposals.

The said case was taken up in 271<sup>st</sup> meeting held on 29.06.2023 and SEAC recommended the Project to SEIAA for **Grant of Environment Clearance**.

# Findings and Decision of THE AUTHORITY (SEIAA):

The said Proposal was taken up during 162<sup>nd</sup> Meeting of SEIAA held on 19.07.2023.

(Upon having seen the details pertaining to the said case, the Authority decided to record similar observations as made in the Item No. 6, above).

The Authority, after having gone through the details and relevant record placed on file, alongwith considering the recommendations of the Appraisal Committee (SEAC), observed and examined that the proposal pertaining to enhancement of Production Capacity from existing 10 MTPA to 24 MTPA. The Appraisal Committee has recommended the same but without any justification. Whereas, the Authority

deemed it appropriate to understand, whether proposed enhancement of production capacity will cause any dent on the Environment and other parameters, upon considering the proposal.

This is due to a recent incident, occurred in District-Bhiwani (Mining Site - Dadam), where many lives were lost and thereafter, it was also found that indiscriminate mining has made serious dents on the Environment / local surroundings by disturbing the eco-system (fauna & flora) and adversely affecting the normal life of the people. Hon'ble NGT also made serious observation and constituted a team of Experts to study and understand the reasons, leading to such unfortunate incident.

Therefore, it is more than imperative and urgent to understand, before considering, such proposals, where production capacity of this magnitude i.e. 10 MTPA to 24 MTPA is proposed to be enhanced, without expressing justification and possible dent on the Environment. The Authority is of the view that Appraisal Committee, while considering such proposals should have sought reasonability and circumstances for considering the proposal of enhancement of this magnitude. Therefore, a response needs to be called from Mines & Geology Department, Haryana in this regard.

Representations dated 30.06.2023 & 13.07.2023, received from the Village Panchayat and other bodies, opposing the proposal, needs to be looked into in the fairness and propriety of the things pertaining to their interest, being the stack holders in the local area, so that propriety and genuinity of their plea can be understood.

Therefore, the Authority decided to constitute a Sub-committee of the followings:

- 1. Member Secretary, SEIAA (Head of the Sub-committee)
- 2. Member Secretary, SEAC (Member)
- 3. Representative of Member Secretary of HSPCB (Member)
- 4. Mining Officer, Bhiwani (Member)
- 5. Regional Officer of HSPCB of the relevant area (To assist the Sub-committee)

The Sub-committee shall visit the project site and submit a detailed report about the proposal, alongwith hearing the representations received in this case.

In view of the above, the **Authority decided to REFER BACK the case to Appraisal Committee (SEAC)** to re-examine the issues of capacity enhancement. Further, the Appraisal Committee needs to look into the precedents, if any and the circumstances and justification for considering such proposals.
