Agenda-A: -Complaints/letters –

1. Sand Mining at Dhobaha Nallah at Gata – 41, 55, 56, 107, Village- Jaitapur Dhobaha, Tehsil – Tulsipur, District- Balrampur, U.P. (Area – 6.07 Ha) File no- 3889

SEIAA gone through the undated letter of Shri Manish Kumar Shukla, Balrampur and Director, Mining dated 31.07.2020 regarding transfer of Environmental Clearance to the above project issued vide letter no. 127/Parya/SEAC/3889/2017 date 29.01.2018. SEIAA gone through file and documents and found that the above Environmental Clearance was issued to Shri Vinay Singh, Village- susela, thana –Tarabganj, Gonda. SEIAA noted that the previous lease issued to Shri Vinay Singh, was cancelled vide DM, Balrampur order no. 4088/Kha.li-Khanan patta nirastikaran/2019 dated 30.03.2019 and another LOI was issued to Shri Manish Kumar Shukla, M/s Tanman sports and general order supplier, R/o Mo. Nai bazar major chauraha, Balrampur vide DM, Balrampur letter no. 6228/Khanij/E-tender/Sehmati patra Jaitapur Dhobaha /2020 dated 23/06/2020. Hence SEIAA opined to transfer Environmental Clearance issued vide letter no. 127/Parya/SEAC/3889/2017 date 29.01.2018 from Shri Vinay Singh, Village- Susela, thana –Tarabganj, Gonda to Shri Manish Kumar Shukla, M/s Tanman sports and general order supplier, R/o Mo. Nai bazar major chauraha, Balrampur. Rest all the content of Environmental Clearance letter shall remain same.

Agenda-B:-Replies-

1. Jaypee Greens, Sports City East Part III, Sector- 19 , District-Gautam Buddha Nagar,U.P., M/s Jaypee Infratech Limited. File No. 5529/Proposal No. SIA/UP/NCP/50919/2020

SEIAA noted that the above project was taken in its meeting dated 19.06.2020 in which SEIAA noted that SEAC has recommended to issue the additional ToR;s to the title proposal for conducting EIA studies but only form-1 is available in the file. Secretariat informed that project proponent has been asked to submit the presentations/all relevant details in hard copy by 04.06.2020 but it has not been submitted till 19.06.2020. Also it is not clear whether the present project proposal is for amendment, revision, expansion or new Certified Compliance Report of MoEF&CC for the previous EC is also not available in file. SEIAA directed the Nodal Officer to put up the complete file along with all the documents as and when made available by project proponent and place it to the next meeting. The project proponent has submitted the reply vide letter dated 07.07.2020. After reviewing the reply SEIAA agreed with the recommendation of the SEAC to issue the additional ToR;s to the title proposal for conducting EIA studies. The SEIAA also added the following points to TOR;-

- 1- All pages of technical documents/EIA/EMP etc. should be signed by the consultant and project proponent both.
- 2- Copy of all the analysis reports duly signed by analyst approved by NABL or MoEF&CC shall be annexed with the EIA report and original analysis reports should be presented at the time of presentation.
- 3- MOU signed between the project proponent and the consultant should be submitted.
- 4- The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 and submit along with EIA.
- 5- If the proposed project falls in Critically Polluted Areas (CPAs), Severely Polluted Areas (SPAs) the provision of the mechanism framed regarding compliance of Hon'ble NGT order in OA 1038/2018 dated 19-08-2019 by MoEF& CC, Govt. Of India vide letter dated 31-10-2019 shall be followed in letter and spirit.
- 6- All the additional condition for grant of Consent to Establish (CTE)/Consent to Operate (CTO) related to Pollution mitigation measures as prescribed in the office memorandum of MoEF&CC, Gol dated 31.10.2019 and as deemed fit by UP Pollution Control Board in the consent orders shall be followed by Project Proponent.
- 7- SEIAA opined that the project proponent shall submit permission of CGWA or proposal for alternative source of fresh water.

2. Sand Mine on Yamuna River at Gata No.-2/9, 2/10, 2/11, 3, 4mi, 5/2, 2/4, 19/3, 19/8, 19/2, 22, 9/4, 19/7,21/1,21/2,21/3,21/5,23/2, at Village-Mamaur Ahatmal Sabik, Tehsil-Kairana, District-Shamli., M/s M.M. Traders (Leased Area- 15.818). File No. 4416/Proposal No. SIA/UP/MIN/75917/2018 13.07.2020 *SEZ PR*

SEIAA gone through the letter dated 24.06.2020 of Shri Vijendra Singh, Aligarh, regarding illegal mining. SEIAA opined to refer the letter to DM, Aligarh and DGM for necessary action.


3. Affordable Housing Project at Village-Gohodi Bahceda, Sector-Mu II, Greater Noida, District-Gautam Buddha Nagar., M/s Greater Noida Industrial Development Authority. File No. 5267/Proposal No. SIA/UP/MIS/46462/2018


SEIAA noted that the above project was taken in its meeting dated 26.02.2020 in which SEIAA opined that proposal for reuse of treated waste water in flushing should be submitted along with the proposal of dual plumbing system etc. SEIAA also noted that nursing home is also being proposed and hence the project proponent should also submit the amount and treatment detail of liquid effluent generated from nursing home. The project proponent has submitted his reply. SEIAA reviewed the reply and found it unsatisfactory. STP of suitable capacity shall be proposed at the site and treated waste water shall be used for flushing, horticulture etc. Remaining untreated waste water can be treated in CSTP as proposed. Proposal of tanker for supply of treated water from CSTP for recycle purpose at the site is not practical. 12 KLD of liquid Bio-medical waste will be generated from Nursing home for the treatment of which separate proposal of ETP has not been submitted. Its treatment in STP is not acceptable. For liquid biomedical waste separate ETP shall be proposed.

4. Building Stone (Khanda, Gitti & Boulder) Mine for Capacity Expansion at Gata No.-967, Khand No.-02 at Village-Kabrai, Mahoba, District- Mahoba, U.P., (Leased Area -3.036 ha.), M/s C.P.S.K. Ventures Pvt. Ltd. File No. 5183/Proposal No. SIA/UP/MIN/46113/2019

The SEIAA agreed with the recommendation of the SEAC to issue the additional ToR;s to the title proposal for conducting EIA studies. The SEIAA also added the following points to TOR;-

- 1- All pages of technical documents/EIA/EMP etc. should be signed by the consultant and project proponent both.
- 2- Copy of all the analysis reports signed by analyst approved by NABL or MoEF&CC shall be annexed with the EIA report and original analysis reports should be presented at the time of presentation.
- 3- MOU signed between the project proponent and the consultant should be submitted.
- 4- The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 and submit along with EIA.
- 5- The lease area its address and production per annum should match with as mentioned in DSR and Lol. In case there is any difference clarification/ amendment letter from competent authority shall be submitted along with EIA. EIA and public hearing shall be conducted as per the lease area its address and production per annum mentioned in DSR and Lol.

The SEIAA noted that SEAC has recommended to grant the environmental clearance for the above project proposal. SEIAA gone through file and documents and found that project proponent has been asked to submit the presentations/all relevant details in hard copy by 27.07.2020 but it has not been submitted yet. SEIAA directed the Nodal Officer to put up the complete file along with all the documents as and when made available by project proponent and place it in the next meeting.



2. **Sand/ Morrum Mining from Betwa River Bed at Khand No.-8/4, Village- Naithi, Thesil-Sadar, District-Hamirpur, U.P., M/s Kuber Kamna Marbles Pvt. Ltd., (Leased Area: 38.866 ha.). File No. 4497/Proposal No. SIA/UP/MIN/29162/2018**

The SEIAA noted that SEAC has recommended to grant the environmental clearance for the above project proposal. SEIAA gone through file and documents and found that Tehsil for the above project is Hamirpur and not Sadar as mentioned in committee minutes. SEIAA agreed with the recommendations of the SEAC to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC adding following specific condition as follows:-

1. Directions/suggestions given during public hearing and commitment made by the project proponent should be strictly complied.
2. The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 before the start of work.
3. The mining lease holders shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora fauna etc.
4. If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.

5. Sand/Morrum Mining of Yamuna River bank at Gata No.-299, 300, 305, 306, 325mi, 326mi, 327mi at Village-Adhawal, Fatehpur, U.P., Area: 15.0 Ha. File No. 5727/5443/Proposal No. SIA/UP/MIN/54632/2020

The SEIAA noted that SEAC has recommended to grant the environmental clearance for the above project proposal. SEIAA gone through file and documents and found that cluster certificate is one and half years old and also the lease area is not given in the DSR. Hence SEIAA opined that the project proponent should submit the same.

6. Building Stone (Khanda, Gitti & Boulder) Mine at Gata No.-93, Khand No.- 30 at Village- Bari, Tehsil & District- Mahoba, U.P., (Leased Area -1.012 ha.). File No. 5519/4913/Proposal No. SIA/UP/MIN/50744/2019


