The Project proponents are requested to attend the meeting in person or depute a competent person having proper & full background of the proposed project with proper authorization in writing Capacity-Authority Letter), who can explain the project and also respond to the queries & offer his views on suggestions made by the committee. Such person would be required to make a presentation on the salient features of the project, the related environmental issues, risk assessment and proposed Environmental Management Plan. His commitment before the committee will be treated as your commitment.
