

31. Serial No. 54: This proposal was considered in 5.47th meeting of SEIAA and it was deferred for expired LoI. Now, the PP has submitted lease sanction order for ML No. 03/2018. Hence, the Authority decided to approve EIA/EMP and grant EC to this proposal subject to condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

32. Serial No. 55, 56: These proposals were considered in the 5.45<sup>th</sup> meeting of SEIAA and a few major shortcomings were identified which have now been rectified by the proponent. Hence, the Authority decided to grant EC to these proposals.

33. Serial No. 57: This proposal was considered in the 5.50<sup>th</sup> meeting of SEIAA and addition information was sought on non-availability of land document. Now, the PP has submitted the required information. Hence, the Authority decided to grant EC to this proposal.

34. Serial No. 58: This proposal was considered in 5.46<sup>th</sup> meeting of SEIAA and was deferred for revised cluster certificate, PFR and NABET Certificate. Now, the PP has submitted the required information. Hence, the Authority decided to grant EC to this proposal.
