The proposals (agenda Item No. 01 to 05) was discussed on 25<sup>th</sup> November, 2019 by SEAC & the SEAC has recommended for grant of Environmental Clearances.

**Consideration & Resolve of the SEIAA:-**

After recommendation of SEAC vide its proceeding dated 05.12.2019; SEIAA considered all these 05 sand mining proposals in its scheduled meeting of 13-12-2019. SEIAA found that in all these cases of Sand Mining in River Kiul and Jhanjhi in the district of Lakhisarai and Jamui by M/s Westlink Trading Private Limited, the validity of lease was to expire on 31-12-2019. The remaining period of validity being short and hardly enough to complete preparatory activities on the site and to obtain other approvals / work orders from different departments / authority; SEIAA declined to grant Environmental Clearance as it would not have served its purpose, however SEIAA otherwise found applications in order. SEIAA also resolved that if the situation so arises for any extension of lease by the competent authority, grant of Environmental Clearance shall be considered as per EIA Notification, 2006.

Incidentally the department of Mines and Geology, Govt. of Bihar vide its letter No. 4949/M, Patna, dated 27-12-2019 did extend lease period upto October 2020 or the date by which new lessees obtain Environmental Clearances and work orders from competent Authorities whichever is earlier. The Project Proponent (M/s Westlink Trading Private Limited) has informed vide its letter dated 29-12-2019 addressed to Member Secretary SEIAA that their lease now stands extended till 31-10-2020.

In this background SEIAA having considered all 05 applications of the Project Proponent has *resolved to grant Environmental Clearance* to all the proposals under consideration subject to additional specific conditions mentioned below:-



- (i) The Project Proponent shall submit copy of extended Mining Plan from competent authority valid upto 31.10.2020 or lease period whichever is earlier, to SEIAA before starting any mining activity.
- (ii) *The onus of a mine being operational only after having valid "Mining Plan" shall lie on the Department of Mines and Geology, Govt. of Bihar as envisaged / provided in "Sustainable Sand Mining Guidelines 2016" of Ministry of Environment, Forest and Climate Change, Govt. of India as well as directions of various courts.*

Earlier, in its meeting dated 25<sup>th</sup> January 2019 the SEAC had observed that the Project Proponent has already started construction work on site which is violation of EIA Notification, 2006 which required to be dealt under provision of Notification S.O. 1030 (E) dated- 08.03.2018 of the MoEF&CC, Govt. of India. The Committee took exception to this violation and directed the Project Proponent to submit a revised proposal containing details of construction etc, along with full facts about violation (for issue of specific revised ToR with reference to violation). The Proponent and Consultant presented details before the committee. The Committee recommended ToR with specific reference to violation (S.O. 1030 (E), dated 08.03.2018) and accordingly the SEIAA issued ToR vide F. No. SIA/1(c)/428/17, dated 11.04.2019. However, since Public Consultation has already been done on 30.09.2018, no fresh Public Consultation asked for.

The Proponent and Consultant presented the proposal before the Committee, and the proposal was considered in pursuance of the Notification No. S.O. 1030 (E) dated 08.03.2018.





The SEAC in its meeting of 27<sup>th</sup> & 28<sup>th</sup> February, 2020 decided to recommend the proposal for grant of Environmental Clearance with all suggested general conditions as well as site specific additional conditions mentioned below:-

- a) The amount prescribed for remediation, natural & community resources augmentation for ecological damage totaling Rs. 280 lakhs shall be remitted in the form of bank guarantee to Bihar State Pollution Control Board, before obtaining Environmental Clearance and the proponent shall submit the acknowledgement of the same to SEIAA, Bihar. The funds to be utilized for the remediation plan, Natural and Community resources augmentation plan as indicated in the EIA / EMP report.
- b) The Proponent required to undertake and complete the activities listed under Environment Management plan for a total amount of Rs. 749.83 lakhs.
- c) The amount specified as Environment Management plan is Rs. 749.83 lakhs separately which will not be adjusted towards remediation and community Resources Augmentation Plan.
- d) The Project Proponent shall carry out the works assigned under Ecological damage, Natural and community resource augmentation within an initial period of six months.

**Specific condition:**

- a. The reservoir shall be declared as a Conservation Reserve in accordance with the provision given u/s 36A of the Wild Life (Protection) Act, 1972 as amended upto 2006 in consultation with the Department of Environment, Forest & Climate Change, Govt. of Bihar.
- b. The area shall be developed as an ecotourism hotspot with adequate security arrangements.

**Resolve of the SEIAA:-**

In light of the recommendation of SEAC, the SEIAA *resolved to grant Environmental Clearance* with all suggested site specific additional conditions. SEIAA however felt the need to modify one of the specific condition imposed by SEAC as mentioned below:-



- (i) The Water Resources Department (here P.P.) and the State Government shall explore the scope & suitability of the site for declaring the water-body as well as its surrounding as a protected area especially for Birds and important terrestrial wild animals locally available under appropriate sections of the Wildlife (Protection) Act, 1972 in consultation with Department of Environment Forest and Climate Change, Govt. of Bihar.
- (ii) In due course the spot may be developed as an eco-tourism hotspot with adequate security arrangements.

Application along with filled up 'Form - I', Form - I (A) and Conceptual Plan in the prescribed format was submitted to SEIAA, Bihar on 13<sup>th</sup> January, 2020 for obtaining Terms of Reference (ToR).

The SEAC in its meeting of 27<sup>th</sup> & 28<sup>th</sup> February, 2020 after hearing the proposal decided that there is no requirement of a separate ToR as this project is a subset of "Redevelopment project of PMCH" and hence recommended to incorporate all the environmental concern for this unit EIA study as is to be undertake for the "Redevelopment project of PMCH (File No. - SIA/8(b)/696119, Online Proposal No.:- SIA/BR/NCP/47134/2019)" for which ToR has been recommended. As such the proposal shall be dealt with together as an integrated project. However a separate chapter needs to be submitted in EIA report dealing with following environmental concern for instant project:-


- a. Quantification of all solid waste and its disposal scheme.
- b. Water balance chart.
- c. Layout and design of STP.
- d. Internal Traffic circulation plan.
- e. Fire Safety and evacuation plan to deal with any emergency situation.



- f. Planning of all entry and exit gates of the entire project on the basis of comprehensive air modeling based on one month additional background ambient air quality data (march- May)

**Resolve of the SEIAA:-**

In light of the above SEIAA agree with the recommendation of SEAC.
