

The SEIAA discussed in detail the recommendations of SEAC, the Lr.No. E.E./Irr.Div-2/Kmm/D.E.E/A.E(T)/2022/268 dt: 24.06.2022, the ADS reply dt: 27.01.2025 submitted by the proponent., Irrigation letter L.No.E.E./Irr.Div-2/Kmm/D.E.E(T)/AEE(T)/J.T.O/2025 dt:26.04.2025 and ADS reply letter dt: 09.05.2025 submitted by the proponent. Hence, approved the project for Environmental Clearance with the following specific conditions:

1. As per the EE, Irrigation Division No.2, Khammam letter dt:24.06.2022, instructed to takeup construction of extra 2 vents with each vent bed width of 3 meters and guidewalls height of 8 feet (2.6 meters including F.S.D & F.B) to accommodate the cumulative discharge in the stream, particularly in monsoon season.
2. The proponent shall complete the construction of extra vents as per the specifications of I&CAD dept. to ensure free flow of stream/storm water during the monsoon season without leading to inundation in the upstream side i.e., in Pakabanda & Allipuram areas and surrounding area at Gangamma thalli temple, before taking up the construction of the project. The proponent shall be held responsible for any lapses / deviations in this regard.
3. The proponent shall obtain all necessary permissions from the Khammam Municipal Corporation.

Further, the proponent is directed to comply with the following additional conditions:

1. The proponent shall make an arrangement for maintenance contract with any operator of the STP for a minimum period of 10 years and shall be extended from time to time.
2. The proponent /Builder shall ensure that the environmental issues (Sewage treatment, Solid waste management) shall be addressed even after handing over the building to the association members. The proponent shall make an agreement with the Residential Association members.
3. The proponent shall ensure that the Sewage generated is properly treated and shall be reused at the maximum extent for gardening/avenue plantation.
4. The proponent shall obtain connections from HMWS&SB or local municipality for water supply and sewerage.
5. The proponent shall comply to Ministry's OM dt:24.07.2024 for plantation in the earmarked green belt area as part of tree plantation campaign "Ek Ped Maa Ke Naam".
6. The project proponent shall upload self-certification report in the parivesh portal as per format every year on 1st June and 1st December.
