In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022. SEIAA opined to accept the recommendation of SEAC-1 and grant Environment Clearance to the said project.

# Gitti Boulder (Dolo Stone) Mining at Araji No:-4478 Chha, Village-Billimarkundi, Tehsil -Obra District-Sonbhadra, Shri Rajeev Kumar Sharma, Area 1.80 ha. File No. 7062/6749/Proposal No. SIA/UP/MIN/ 76421/2021

SEIAA noted that SEAC has recommended to grant EC to the above project. SEIAA gone through file and documents and found that in MOM Total Geological Reserves is mentioned as 11,22,478 m3 whereas Total Proposed Production (for 20 year) is mentioned as 11,52,000 m3, which is more than the total geological reserve. It is being observed that consultants are giving data without even looking into its merit and SEAC-1 is also not scrutinizing it. SEAC-1 is advised to be more careful in examining the date given by PP / consultant. Hence, SEIAA opined to refer back the project to SEAC-1 for review/comments.
