POINTS OF DEFER FOR PROPOSALS OF MINING SECTOR:

1. SEAC has examined and found that project fulfills the prescribed and applicable criteria of EMP and has also noted that the TOR conditions have been fulfilled. However, the EMP table does not include measure such as discharge of water, if any, control of fugitive emission during loading and unloading, transportation, post closure liability, noise control and compliance cost of commitment given during public hearing and disposal of mining

waste/debris which is not required for back filing, cost of laboratory analysis if any. etc. Final use of reservoir/reclaim mines and fencing to prevent loss of wildlife and human movement. EMP table shows expenses for Air Pollution Mitigation without giving any content or value/cost of mitigation.

2. SEAC is requested to examine the approved TOR/EIA report/proposal of the proponent/minutes of SEAC meeting and submit the compliance if details are available, if not available, shall obtain all details and documents from proponent and reconsider the proposal and submit its recommendation for decision of SEIAA.
3. Accordingly, SEAC may advise the consultants to follow a common EMP table keeping the contents suggested in point no. 1 as far as possible.
4. Any other item suggested by SEAC may also be included during the presentation before SEAC.
5. In the case of the cluster, the sharing of EMP cost by the proponents should be affirmed by notarized undertaking.
