


SEIAA Resolution 7/1:

SEAC Resolution 9/3:

The proposal submitted by Sri Ranjit Basumatary for extraction of EC granted by SEIAA, Assam dated 17/10/2020 for another 2(two) years as per approved Mining Plan requesting to extract 6000Cu.M of stone, 2000 Cu.M Ordinary Sand and 4000 Cu.m Ordinary Clay/ Earth from the Unniguri River MCA under Baksa Forest Division.

On scrutiny of the proposal, it is seen that the project proposed on Periodic Khiraj Patta land where it is clearly mentioned that if the land is used other than agriculture practice the land owner has to pay enhance land revenue for the particular plot of land.

On Scrutiny of the Proposal it is also seen that the proposal has received at the office of SEIAA, Assam on 19th Nov, 2019 but due to non-functioning of the committee followed by lockdown imposed by the Govt. the same could not be processed in time. On the other hand, the project proponent was submitted to fulfill the requirement of the Govt. work and accordingly the mining period was asked up to March/20.

The committee after due deliberation and considering the facts stated above approved the project subject to production of record of payment of land revenue on enhance rate. The SEIAA may consider issuing EC for extraction of 50,000Cu.M of Ordinary Earth within a period of 60 days from the date of issue of EC considering the above discussion.





SEAC Resolution 9/10:

The project proposal for extension of EC submitted by Tribeni-Mahabala (JV) for mining of Silt from Borbhita MPA, Gumi under Kamrup West Division has been discussed in the meeting. On deliberation, it is found that EC was granted vide date 21-01-2020 against collection of silt 35000Cu.M for 2 (two) years. SEAC Resolution 9/19:

The Project proposal for extraction of river bed Ordinary Earth from 4.50 Ha area at Jiabharali River Bed ordinary earth MPA under Sonitpur East Forest Division submitted by M/S Simplex Infrastructure Ltd is examined in the meeting. On deliberation it is seen that the project proponent requested for 1,00,000Cu.M of earth from the proposed site in 2 (two) years.
