1. Bio Medical Waste Plant at Gata No.-295Mi, Village- Fathepur Vishnoi, Moradabad, U.P., M/s Sushila Bio Medical Waste Plant File No. 4650/ Proposal No. SIA/UP/MIS/30923/2019

Joint inspection report of M/s Sushila Bio Medical Waste Plant in the matter of OA number 273/2020 of joint committee comprising of CPCB, SEIAA, UPPCB & DM Moradabad was placed before SEIAA. SEIAA noted that the above project was appraised in joint SEIAA/SEAC meeting dated 25-05-2021 in which it was decided that the following additional conditions should also be imposed in the existing Environmental Clearance to ensure all environmental safeguard measures:

- 1- Clean fuel must be used to operate incinerator installed in the proposed CBWTF with appropriate air pollution control systems so that the adverse impacts of the emissions may be mitigated.
- 2- There must be a provision of at least 10 meter height wind break/wind breaking wall on the side of the residential area and school on the boundary of CBWTF.
- 3- Appropriate measures like proper housekeeping etc. must be adopted for control of odor likely to be originated from CBWTF.



- 4- A three tier plantation of large trees, small trees and shrubs having high APTI (Air Pollution Tolerance Index) should be planted at the boundary.

SEIAA gone through the Joint inspection report and agreed with the recommendation of the joint committee to also add following conditions given in report dated 28-10-2021 in issued environmental clearance:-

- 1- To control the odour which emanate due to handling of bio-medical waste specific arrangement such as spray of specified chemical/solutions required to be made by the facilities in the storage area of BMW.
- 2- The facility shall identify time period/ duration when the movement of school children around the facility is either negligible or minimum and accordingly movement of loaded vehicle with BMW, must be planned.
- 3- Design of the Mechanical feeding systems of BMW to incinerator required to be improved by covering the conveyer belt appropriately to prevent the spillage of BMW.
- 4- The Air Pollution Control Devices (APCD) installed in the facility shall be operated and maintained as per design provided by the supplier specially two-second residence time in secondary chamber and other scheduled maintenance.
- 5- The facility must ensure the implementation of Standard Operating Procedure (SOP) and Preventive Maintenance Schedule (PMS) particularly the change/maintenance of the baffles of droplet separator, media of packed bed scrubber etc. in the plant.
- 6- The arrangement of the LED Display system for controlling operational parameter of incinerator such as temperature, gas composition etc., shall be made appropriately.
- 7- For the better housekeeping in the facility, the facility must ensure laying/fixing of appropriate kind of tiles within the premises particularly in ETP area, storage area of BMW and other area as per requirement.
- 8- The facility must be operated as per the provision of Bio-Medical Waste Management Rule 2016 and amendment thereof as well as prescribed Guideline for the purpose concern by CPCB.
- 9- The facility must be monitored on quarterly basis by the prescribed authority to ensure the compliance of prescribed norms as well as direction given by Hon'ble NGT, New Delhi in O.A. No. 273/2020 order dated 11-08-2021.
