3. The directions issued by the Hon'ble NGT, Southern Zone, Chennai in the matter of O.A.No. 47 of 2016 (SZ) & 177 of 2016 (SZ), Order dated:14.12.2020 shall be scrupulously followed.
4. The boundary pillars shall be erected with geo co-ordinates marked on them.
5. No sand mining shall be done during the rainy season.
6. The ramp (i.e., approach road) shall be removed after sand mining is completed.
7. The standard environmental conditions for sand mining specified in the Sustainable Sand Mining Guidelines, issued by MoEF&CC, Govt of India, 2016 shall be followed.
