As referred to the notification issued by the MoEF&CC dated 1st January 2016, it is mandatory to prepare District Survey Report (DSR) & proper mining plan before obtaining prior Environmental clearance for the projects with respect to mining of minor minerals, however the Committee has not found such reports in the application submitted by the Directorate of Mines & Geology.

And further after scrutinizing the order passed by the Honble NGT in the matter title "Sudarsan Das V/s Sate of West Bengal & Ors" and "Satendra Pandey V/s Ministry of of Environment and Climate Change and Anr dated 4 September 2018 and 13th September 2018 respectively, the Committee has come to the Conclusion as follows
