The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1: The proposal was deferred in the 5.105th meeting of the SEIAA due to
 non-submission of Certificate from DCF WL, Udaipur and DCF, Udaipur.

 Now, PP has submitted a Certificate from DCF, Pratapgarh vide letter dated
 31.01.2024 with the clarification that as per "List of Revenue Villages for which
 certificate of distance from Forest Boundary/Protected Area Boundary is not
 required" issued by Forest Department, Government of Rajasthan, Tehsil Lasadiya is
 a part of DCF, Pratapgarh. Hence, the Authority accepted the recommendations and
 additional conditions of SEAC and decided to grant EC to this proposal.
- 2. Serial No. 2: Proposal was deferred in the 5.114th meeting of SEIAA as there was no dispatch number and date on the Aravalli Certificate submitted with the proposal and also the affidavit regarding implementation of Cluster EMP was not submitted. Now, PP has submitted an affidavit regarding implementation of Cluster EMP and revised Aravalli Certificate. Hence, The Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP for production capacity of 4,89,158.25 TPA as approved in Cluster Mining Plan and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 3. Serial No. 3, 9: The Authority decided to <u>defer</u> these proposals in light of the O.M. No. IA3-3/4/2024-IA.III [E 230791] dated 08.01.2024 issued by MoEF&CC regarding stay imposed by Hon'ble Supreme Court in W.P.(C) No. 1394/2023 titled Vanshakti vs. Union of India, with reference to the SOP dated 7th July 2021 and OM dated 28th January 2022.
- Serial No. 4, 23, 30, 31, 33, 34, 38, 39, 40, 41, 42: The Authority accepted the
 recommendations and additional conditions of SEAC and decided to grant EC to
 these proposals.
- Serial No. 5: In this proposal, the affidavit regarding implementation of Cluster EMP
 has not been submitted. Hence, the authority decided to <u>defer</u> this proposal for





- additional information i.e., submission of affidavit regarding implementation of Cluster EMP within 45 days.
- 6. Serial No. 6: The Authority decided to accept the recommendations of SEAC and decided to close and delist this proposal.
- 7. Serial No. 7: The Authority decided to accept the recommendations of SEAC and decided to approve the release of Bank Guarantee of this proposal to PP.
- 8. Serial No. 8: The Authority decided to defer this proposal for detailed presentation. In particular, PP shall explain the parking provisions provided along with the peak population expected as well as delineate parking places for residents, shop owners, staff and visitors. Also, indicate whether they have applied for NOC from CGWA. In regard to the construction done on site, PP is required to submit photos of the site at the time of presentation.
- 9. Serial No. 10: In this proposal, there is a mismatch in the given numbers of Rainwater Harvesting structures in presentation and Form I. Also, the NOC from CGWA has expired. Hence, the Authority decided to defer this proposal for submission of additional information i.e., submission of correct no. of RWH structures and valid NOC from CGWA in next 45 days.
- 10. Serial No. 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 24, 25, 26, 27, 28, 29, 36: The Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 11. Serial No. 32: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal with the condition that PP shall ensure all the conditions imposed by WRD in the issued certificate.
- 12. Serial No. 35: In this proposal, affidavit regarding implementation of Cluster EMP and regarding violation/no violation has not been submitted. Hence, the Authority decided to defer this proposal for additional information i.e., submission of affidavit regarding implementation of Cluster EMP and regarding violation/no violation within 45 days.
- 13. Serial No. 37: The Authority decided to defer this proposal to accord an opportunity of presentation to PP to explain the proposal in details.

- 14. Serial No. 43: In this proposal, condition no. 15 of submitted Certified Compliance Report is mentioned as not complied. Hence, the Authority decided to <u>defer</u> this proposal for submission of ATR in next 45 days.
- 15. Serial No. 44, 45, 46, 48 to 56: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2024 issued by MoEF&CC.
- 16. Serial No. 47: The Authority decided to grant Transfer EC to this proposal.
