The proponent applied for EC for construction of Residential Duplex Villas with builtup area of 53,924.68 Sq.m. in total plot area of 57,710.0 Sq.m. under 8(a) Category. The SEIAA in its meeting held on 14.02.2022 reviewed the recommendations of SEAC and approved the project for issue of EC. Meanwhile, a complaint was received on 25.02.2022 stating that the proponent has started construction of Villas without obtaining EC and furnished the wrong information. Hence, the issue of EC order was kept in abeyance.


In order to verify the facts, a Sub-Committee with SEAC, Members visited the site on 09.04.2022 and observed that i) The construction of Villas was started without obtaining EC. ii) The proponent and the consultant furnished the wrong information during presentation. iii) The proponent submitted HMDA draft Layout permit dt.12.02.2021 for development to the extent of 48,750.1 Sq.m. iv) The map enclosed to the NOC from I&CAD Dept, and the site layout mentioned in the presentation are not in conformity.

The Sub-Committee report is reviewed and noted that the project proponent has started construction activity without prior EC and also submitted wrong information along with application and also during the SEAC meeting. The commencement of construction activity without prior EC amounts to Violation of EIA Notification, 2006. Hence, the project is rejected.

The proponent is also directed to comply with the MoEF&CC, GoI, OM No22-21./2020-IA.III dt.07.07.2021.
