- ii. As per the MoEF & CC Govt. of India O.M. dated 08.08.2019 and letter vide letter no. F. No. 6-60/2020 WL Part (1) dated 16.07.2020 if, a proposals involving developmental activities/projects located within 10 km of National Park/Wildlife Sanctuary wherein final ESZ notification is not notified(or) ESZ notification is in draft stage, prior clearance from Standing Committee of the National Board for Wildlife (SCNBWL) is mandatory.
- iii. In light of the above, the Authority rejected the proposal and ask to apply afresh after getting NBWL clearance.
