DELIBERATION IN SEIAA AND SEAC

After detailed deliberations, the committee observed:- **The SEAC in its meeting held on 08.11.19, after detailed presentation by the PP along with consultant noted that the proponent has gone for production of limestone and dolomite without prior EC Clearance under EIA Notification, 2006. The SEAC, after detailed deliberations on the proposal in terms of the provisions of the MoEF&CC, Govt. of India Notification dated 14th March, 2017, confirmed the case to be of violation of the EIA Notification, 2006 and recommended for issuing Standard Term of Reference as per Annexure- A along with the following specific Term of Reference for undertaking EIA and preparation of EMP.**

RECOMMENDATIONS OF SEIAA AND SEAC

The committee's recommendation **State Govt. (Director Environment) may be moved to take legal action for the violation committed against the PP. We may ask the PP to convey its agreement to the specific terms of reference in the TOR issued by SEAC; and await submission by PP of the detailed EIA study report /EMP as per this ToR**
