1. **Proposed River Bed Sand Mining from Yamuna River for M/s Ghanaram Infraengineers Pvt Ltd. located at Gata No.- 138, Village-Bichawali Kachar, Tehsil- Sikandra, District-Kanpur Dehat, U.P., Lease Area- 24.24 ha File No. 4073/Proposal No. (SIA/UP/MIN /72746/2018)**

SEIAA gone through the letter of Shri Satya Prakash Gupta dated 23.12.2020, regarding transfer of Environmental Clearance to the above project issued by SEIAA vide letter no. 238/Parya/SEAC/4073/2018 dated 16.03.2018. SEIAA gone through documents and found that the above Environmental Clearance was issued to Shri Bishan Singh S/o Shri Ghanaram Singh 818 West Patel Nagar, New Delhi for 2,42,400 m³ capacity. SEIAA noted that the previous lease issued to Shri Bishan Singh was cancelled vide DM, Kanpur Dehat, order no. 310/Khanij Lipik/Patta nirastikaran/2019 dated 22.06.2019 and another LOI was issued to Shri Satya Prakash Gupta S/o Shri Om Prakash Gupta M/s Ma Vaishno Agro Industries 128/346 H-Block Kidwai nagar Kanpur vide letter no. 185/upkhanij E-tender Seh e-nilami/sahamati patra/2020 dated 24.03.2020 for 2,66,640 m³ capacity. Hence SEIAA opined that EC cannot be transferred since production capacity is more than the previous production capacity.

2. **Proposed River bed Sand/Morrum Mine Project from Betwa River at Khand No.26/08, Village-Chandwari Ghurouli, Tehsil- Sarila, District-Hamirpur, U.P. M/s Kuber Kamna Marbles Pvt. Ltd. Area 36.437 Ha File No. 4365/Proposal No. (SIA/UP/ MIN /27872/2018)**

SEIAA gone through the letter of Shri Nand Kishor Gupta dated 27.12.2020, regarding transfer of Environmental Clearance to the above project issued by SEIAA vide letter no. 658/Parya/SEAC/4365/2018 dated 31.01.2019. SEIAA gone through documents and found that the above Environmental Clearance was issued to Shri Rajeev Mishra M/s Kuber Kamna Marbles Pvt Ltd 312 Ganpati Plaza, MI Road Jaipur Rajasthan. SEIAA noted that the previous lease issued to Shri Nand Kishor Gupta was cancelled vide DM,



Hamirpur, order no. 5094/Khanij-MMC30 Vividh/2019-20 dated 24.03.2020 and another LOI was issued to Shri Nand Kishor Gupta M/s Balaji Associates S/o Shri Ram Prakash Gupta Tulasi Nagar Urai Jalaun vide letter no. 1118/Khanij MMC-30 vividh/2020-21 dated 24.09.2020 for six months and 364320 m³ capacity. Hence SEIAA opined to transfer Environmental Clearance issued vide letter no. 658/Parya/SEAC/4365/2018 dated 31.01.2019 from Shri Rajeev Mishra M/s Kuber Kamna Marbles Pvt Ltd 312 Ganpati Plaza, MI Road Jaipur Rajasthan to Shri Nand Kishor Gupta M/s Balaji Associates S/o Shri Ram Prakash Gupta Tulasi Nagar Urai Jalaun with the condition that the EC will not be transferred further and after 6 months the EC will be null and void. Rest all the content of Environmental Clearance letter no. 658/Parya/SEAC/4365/2018 dated 31.01.2019 shall remain same.

Area mentioned in the previous EC is being transferred only. If there is a change in geo-coordinates of the area then EC will be null and void.

3. Transfer of Environment Clearance for ordinary sand mining khand no. Gha(Block 20, Gata no. Gha), lease area 5.0 ha, village- Ratanpura, Tehsil-Gola, District- Gorakhpur, Uttar Pradesh.

SEIAA gone through the letter of Smt. SEIAA noted that complete cancellation order of the above lease is not annexed with the application. Hence SEIAA opined that project proponent shall submit the same.

- 4- The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 and submit along with EIA.

In case there is any difference clarification/ amendment letter from competent authority shall be submitted along with EIA. EIA and public hearing shall be conducted as per the lease area its address and production per annum mentioned in DSR and Lol.
- 6- Public hearing shall be conducted as per EIA notification, 2006 (as amended).
