- The project proponent shall submit within the next 3 months the schedule for training of various categories of employees involved in Bio-medical waste management at various levels of Bio-medical waste generation in hospital along with the name of experts etc.
- The project proponent shall engage the agency authorized by UPPCB for Biomedical waste collection, transportation, disposal and treatment.
- The project proponent shall submit within the next 3 months the details on quantification of year wise CSR activities along with cost and other details.
