
General Discussion:-

Secretary, Geology and mining UP, Lucknow has requested SEIAA vide letter no. – 1818/86-2020 dated 09.10.2020 to dispose off mining projects on priority basis. SEIAA opined to accept it and take mining/Government/Public Interest projects on priority basis.

SEIAA gone through the letter of Shri Javed Ali dated 24.12.2020, regarding transfer of Environmental Clearance to the above project issued by SEIAA vide letter no. 173/Parya/SEAC/3985/2017 dated 12.02.2018. SEIAA gone through documents and found that the above Environmental Clearance was issued to Smt. Sunita Singh W/o Shri Ravi Raj Singh 53A, Shakti Nagar, Chaka, FCI, Karchhana, Allahabad.
