Agenda A- Replies

- 1- **Proposed Project "IT Park" at Plot No.-2, Knowledge Park- III, Greater Noida., Shri Sahil Gupta, M/s Dhampur Alco-Chem Pvt. Ltd. File No. 6631/Proposal No. SIA/UP/MIS/ 234086/2021 (~~6631/Proposal~~)**

SEIAA noted that the above project was taken in its 571st meeting in which SEIAA opined that project proponent shall submit certified compliance report from IRO, MoEF&CC, GoI, Lucknow. The project proponent has submitted his reply vide letter dated 06.04.2022 stating that no work on the project was started in the validity period of earlier EC. Hence SEIAA agreed with the recommendation of SEAC 594th meeting to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC. In addition to the conditions imposed by SEAC the SEIAA added following additional specific conditions:-

- 1- The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
- 2- The project proponent shall ensure to plant broad leaf trees and their maintenance. The CPCB guidelines in this regard shall be followed.
- 3- The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. CER activities must not be less 2% of the project cost. The CER activities should be related to mitigation of Environmental Pollution and awareness for the same.
- 4- The project proponent shall submit within the next 3 months the details of estimated construction waste generated during the construction period and its management plan.
- 5- The project proponent shall submit within the next 3 months the details of segregation plan of MSW.
- 6- The project proponent shall ensure that waste water is properly treated in STP and maximum amount should be reused for gardening flushing system and

washing etc. For reuse of water for irrigation sprinkler and drip irrigation system shall be installed and maintained for proper function. Part of the treated sewage, if discharged to sewer line, shall meet the prescribed standards for the discharge.

- 7- Under any circumstances untreated sewage shall not be discharged to municipal sewer line.
- 8- The project proponent will ensure that proper dust control arrangements are made during construction and proper display board is installed at the site to inform the public the steps taken to control air pollution as per the Construction and Demolition Waste Management Rules.
- 9- The project proponent shall install micro solar power plants, toilets in nearby villages, public place or school from CER fund of the project for which E.C is granted in addition to and water harvesting pits and carbon sequestration parks / designed ecosystems.
- 10- A certificate from Forest Department shall be obtained that no forest land is involved and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Forest (conservation) Act, 1980 and submit before the start of work.
- 11- In compliance to Hon'ble Supreme Court order dated 13/01/2020 in IA no. 158128/2019 and 158129/2019 in Writ petition no. 13029/1985 (MC Mehta Vs GOI and others) anti-smog guns shall be installed to reduce dust during excavation.
- 12- If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.
- 13- Provision for charging of electric vehicles as per the guidelines of GoI / GoUP should be submitted within the next 3 months.

2- Sand Stone Mining at Arazi No 703 (Sl. No. 08), Village- Bhagautidei, Tehsil- Chunar, District- Mirzapur, Area 1.01 ha. File No. 6756/Proposal No. SIA/UP/MIN/69911/2021

SEIAA noted that the above project was taken in its 555th meeting in which SEIAA opined that the project proponent shall submit documents regarding clear identification / inclusion of this area in the DSR. The project proponent has submitted his reply vide letter dated 21.02.2022 along with DSR which states that due to mining policy 2017 execution is pending. Hence SEIAA opined that project proponent/consultant shall submit certificate from competent authority i.e. DM or Director, DGM or under their signature, for inclusion of the area in the DSR.

3- Establishment of Clinker Grinding Unit of capacity: 2 MTPA and DG Set of 1.5 MW at Village-Dhauha, Paragana- Sakteshgarh, Tehsil- Chunar, District- Mirzapur, U.P. of M/s Eco Plus Cement Chunar Pvt. Ltd. File No. 5712/Proposal No. SIA/UP/IND/54294/2020

SEIAA noted that the above project was taken in its 431st meeting in which SEIAA opined that the project proponent shall submit received copy of letter for information regarding collection of baseline data submitted to District Magistrate



and UPPCB. The project proponent has submitted reply vide letter dated 28.01.2022 along with a copy of receiving from UPPCB. Hence SEIAA agreed with the recommendation of SEAC 508th meeting to amend TOR letter dated 11/09/2020 as :

Rest all the conditions mentioned in letter dated 11.09.2020 shall remain same.

4- Assembling of Led Lights & Components at Plot No.- 10, Sector-156, Noida, U.P., Shri Hardeep Singh, M/s Ikio Solution Pvt. Ltd. File No. 6328/Proposal No. SIA/UP/MIS/211400/202

SEIAA noted that the above project was taken in its 556th meeting in which SEIAA opined that the queries raised are not replied satisfactorily. The project proponent submitted his reply vide letter dated 15.03.2022. After going through the reply SEIAA opined that the reply is not satisfactory and directed the project proponent to submit point wise reply. Further SEIAA opined that consultant has adopted casual approach in replying to the queries raised. Thus a show cause notice be issued to the consultant along with copy to QCI / NABET.

5- Pradhan Mantri Awas Yojna at 332, 367, 368, 371, 372, 374, 375, 376, 377, 379, 380, 381, 386, 387, 733, 734, Sector-N, VasantKunj, Village- Bari-Kala, Tehsil- Sadar, District-Lucknow, U.P. File No. 4951/Proposal No. SIA/UP/MIS/112220/2019

SEIAA noted that the above project was taken in its 568th meeting in which SEIAA noted that the project proponent has submitted his reply vide letter dated 3.8.21 but the replies unsatisfactory. Hence SEIAA opined that a letter shall be sent to Chief Engineer, LDA that queries are not being solved by consultant and hence the project is being delayed. The project proponent/consultant has submitted his reply vide letter dated 21.05.2022 along with the reply not signed by the competent authority. Hence SEIAA opined that a show cause notice be issued to the consultant along with copy to QCI / NABET.

6- Mix Use Project "Supernova" at Plot No.- 03, Sector-94, Noida, U.P., M/s Supertech Realtors Pvt. Ltd. File No. 1167/Proposal No. SIA/UP/MIS/231589/2021

This project was taken up in SEIAA meeting no. 565 dated 17.02.2022. Queries raised by SEIAA have not been replied by PP / consultant. PP / consultant are directed to submit to the point reply to the queries. Further SEIAA opined that consultant has adopted a casual approach in making replies to queries, thus show cause notice to be issued to consultant along with copy to QCI / NABET.



7- Group Housing Project at Plot No. GH-01, Sector-118, Noida, Gautambudh Nagar, U.P., M/s IVR Prime Developers (AVADI) Private Limited. File No. 1724/Proposal No. SIA/UP/MIS/231995/2021

This project was taken up in SEIAA meeting no. 565 dated 17.02.2022. Queries raised by SEIAA have not been replied by PP / consultant. PP / consultant are directed to submit to the point reply to the queries. Further SEAll opined that consultant has adopted a casual approach in making replies to queries, thus show cause notice to be issued to consultant along with copy to QCI / NABET.
