

Minutes of the 89th meeting of State level Environment Impact Assessment Authority, Jharkhand held on 05th, 06th & 07th July, 2021.

The 89th meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 05th, 06th & 07th July, 2021 in the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-



The SEAC has scrutinized the above projects in the light of Hon'ble NGT order dated – 13.09.2018, dated – 11.12.2018 and MoEF& CC, OM dated – 12.12.2018. Thereafter, SEAC has made unanimous recommendation for grant of Environmental Clearance of above mentioned projects proposals. The SEIAA based on the recommendations of SEAC unanimously decided to grant Environmental Clearance to the above mentioned project proposals subject to Hon'ble NGT order dated – 13.09.2018, dated – 11.12.2018 and MoEF& CC, OM dated – 12.12.2018.

- a. Providing for EIA, EMP and therefore public consultation for all areas from 5 to 25 Ha falling under category B-2 at par with category B-1 by SEIAA/SEAC as well as for cluster situation wherever it is not provided.
- b. Form-1M be made more comprehensive for areas of 0 to 5 Ha by dispensing with the requirement for public consultation to be evaluated by SEAC for recommendation of grant of EC by SEIAA instead of DEIAA/DEAC.
- c. If a cluster or an individual lease size exceeds 5 ha the EIA/EMP be made applicable in the process of grant of prior Environmental Clearance.
- d. EIA and/or EMP be prepared for the entire cluster in terms of recommendations 5 (supra) of the guidelines for the purpose of recommendations 6, 7 and 8 thereof.

The Authority examined the recommendation of SEAC for above mentioned project proposal for grant of Environmental Clearance. During examination of file it was observed that a plot no. 185 was not mentioned in the certificate issued by the Territorial DFO, Khunti vide letter no. - 2176, dated - 12.12.2017. Hence, after deliberations it was unanimously decided that Environmental Clearance will be issued after getting confirmation from DFO, Khunti regarding the earlier issued letter regarding plot no. 185.

The Authority examined the recommendation made by SEAC for above mentioned project proposal for grant of Environmental Clearance. During examination of file it was observed that as per certificate issued by DFO, Dumka vide letter no. - 1047, dated - 27.05.2020 the distance of proposed project falls under 250 mtrs. from forest land. Hence, after deliberations it was unanimously decided that SEAC should clarify the basis of recommendation for this project, and it was also decided to sent back this project proposal for further examination of the raised issue.

The Authority examined the recommendation made by SEAC in its 88th meeting. SEAC has recommended to issue corrigendum of EC stating Latitude : 24°26'57.04"N to 24°26'55.01"N and daily production of Mine : 589.248 TPD. During examination of records available in file it was observed that SEAC has recommended with per day production of 589.248 TPD which




is as per the approved mine plan, for the first year and is the highest per day production for the entire project period.

Hence, it was unanimously decided that the above mentioned project proposal is being sent to SEAC to explain the basis of their recommendation at the highest per day production. SEAC may examine the project proposal again and recommend per day production after examining the submitted approved mine plan.

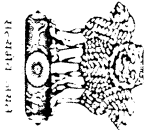
