- 2. Serial No. 2: Proposal was deferred in 5.89th meeting of SEIAA as "Cluster certificate submitted with the proposal was ambiguous". Now, PP has submitted revised cluster certificate dated 03.08.2023. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to this proposal.
- 3. Serial No. 3: Proposal was deferred in the 5.89th meeting of SEIAA because "As per certificate issued by DCF, Kota vide letter dated 25/01/2023, MHTR is at a distance of 1.28 km from the lease area, for which conservation plan is required". Now, PP has submitted a conservation Plan along with an acknowledgment receipt from DCF Mukundara National Park, dated 09/05/2022. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to this proposal.

- 4. Serial No. 4: Proposal was deferred in the 5.88th meeting of SEIAA due to the reason that "Since this proposal is for amalgamation and expansion, CCRs for both mining leases were sought. PP has not submitted latest CCR for ML No. 205/1998". Now, PP has submitted the CCR dated 11/06/2023, for ML No. 205/1998. Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to this proposal.
- Serial No. 5: Proposal was deferred in 5.88th meeting of SEIAA for the following:
  - In Form 6 [Form for ML], ML no. is mentioned as 13/2019 (No date given on agreement or form 6]; but in EIA, note sheet, Aravalli certificate it is mentioned as 73/2018.

Hence, the Authority accepted the recommendations & additional conditions of SEAC and decided to <u>approve EIA/EMP and grant EC</u> to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects, and <u>subject to the condition of receiving of revised abstract from the SEAC.</u>

6. Serial No. 6: Proposal was deferred in 5.89th meeting of SEIAA as "Simplified Mining Scheme submitted with the proposal was valid till 2022-2023". Now, PP has submitted latest Simplified Mining scheme vide letter dated 20/03/2023 (valid till 2027-2028). - 11. Serial No. 14: In this proposal, it is mentioned in the SEAC abstract that "following is the list of leases in cluster" whereas the proposal is of individual lease. Hence, the Authority decided to grant EC to this proposal subject to the condition of receiving of revised abstract from the SEAC.
- 12. Serial No. 20: In this proposal, project proponent has not satisfactorily addressed the issues raised in the public hearing. The matter be referred back to the District Collector Udaipur stating that the issues raised in public hearing seem serious. The District Collector may have site enquiry done to ascertain the same and to suggest measures that will address the issues raised which should be included in the revised EMP for the entire larger cluster of 68.3018 ha. The revised EMP may be sent along with affidavits of each lease holder in the cluster stating that they will adhere to measures incorporated in revised EMP and shall communicate in writing the willingness to contribute their respective share of the funds required for the implementation of the measures incorporated in the revised EMP.

- 13. Serial No. 21: In this proposal, there is gross negligence on the part of the consultant, which are as follows:
  - a. On Parivesh Portal, the name of the applicant is mentioned as Dina Chetan Shah (Company- M/s. Manico) but the hard application is signed by supposed POA (Power of Attorney) Kamalnath Satyanarayan Vyas but no document for POA has been submitted with the proposal.
  - b. Project is of Bhilwara district whereas in the submitted affidavit, the heading of cluster EMP is mentioned as "Undertaking regarding implementation of the cluster EMP near village Bacheriya, Tehsil Deogarh, district Rajsamand."

Considering above, the Authority was of the view that such negligence is not acceptable. Hence, the Authority decided to defer this proposal for submission of revised affidavit regarding implementation cluster EMP along with the document of POA.

Also, the Authority decided to impose a fine of Rs. 5,000/- on the Consultant for submission of wrong affidavit and incomplete documents.

- 14. Serial No. 22: In this proposal, proposed production capacity in PFR seems to have been mistakenly mentioned as 709868 TPA whereas EC is sought for 386988 TPA. The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC subject to the submission of clarification for different figures of production capacity to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 15. Serial No. 29, 30, 31, 32: The Authority decided to grant Transfer EC with the condition that the PPs concerned shall apply for TOR under violation within 45 days. In addition to this RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 16. Serial No. 33, 34, 35: The Authority decided to grant Transfer EC to these proposals.
- 17. Serial No. 36, 37, 38: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA,

the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
