- order in OA 1038/2018 dated 19-08-2019 by MoEF& CC, Govt. Of India vide letter dated 31-10-2019 shall be followed in letter and spirit.
- All the additional conditions for grant of Consent to Establish (CTE)/Consent to
 Operate (CTO) related to Pollution mitigation measures as prescribed in the office
 memorandum of MoEF&CC, Gol. dated 31.10.2019 and as deemed fit by UP Pollution
 Control Board in the consent orders shall be followed by Project Proponent.
- 6. If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.

The project proponent has submitted his reply vide letter dated 22.06.2020 along with Google map but the correct address of the lease has not been submitted. Hence SEIAA opined that a letter shall be sent to DMO Mirzapur for necessary action.

SEIAA noted that the above project was taken in its meeting dated 18.05.2020 in which SEIAA opined that the project proponent shall submit relevant documents regarding its distance from CEPI. The project proponent has submitted his reply vide letter dated 17.06.2020 after reviewing the reply SEIAA agreed with the recommendation of the SEAC dated 19.05.2020. SEIAA agreed with the recommendations of the SEAC to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC adding three specific condition as follows:-

- Directions/suggestions given during public hearing and commitment made by the project proponent should be strictly complied.
- The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 before the start of work.
- The mining lease holders shall, after ceasing mining operations, undertake regrassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora fauna etc.
- In compliance to Hon'ble Supreme Court order dated 13/01/2020 in IA no. 158128/2019 and 158129/2019 in Writ petition no. 13029/1985 (MC Mehta Vs GOI and others) anti-smog guns shall be installed to reduce dust during excavation.
