CONSIDERATION OF COUNTRY LIQUOR PROPOSALS


(I) CONSIDERATION OF COUNTRY LIQUOR PROPOSALS (NEW AND COMPLIANCE FURNISHED):

The committee verified the documents furnished along with checklist of 11 nos. of country liquor proposals. The case-wise proceedings and observations of the committee are detailed in Table as per **Annexure** – **I**. The recommendations of the committee are as follows:

No. of proposal	Recommendation of the committee
10	The Committee decided to take decision on the proposal after receipt of documents / clarification from the proponent.
01	The Committee recommended to return the proposal to SEIAA, Odisha with a request to ask the proponent to apply to MoEF&CC, Govt. of India as Category A project.

(II) CONSIDERATION OF COUNTRY LIQUOR PROPOSAL IN CRITICALLY POLLUTED AREA OF ANGUL- TALCHER.

- a) The SEAC in its meeting held on 31.05.2019 had decided to return 04 nos. of country liquor applications (as per Annexure-II) to SEIAA, Odisha with a request to request MoEF&CC, Govt. of India to advise with Circular or Office Memorandum of MoEF&CC, Govt. of India if any that general condition is not applicable for the projects located within the Critically Polluted Area or within 05 km from boundary of Critically Polluted Area where Moratorium period for such Critically Polluted Area has been lifted.
- b) The SEIAA, Odisha in its meeting held on 27.06.2019 decided to intimate to SEAC, Odisha to appraise the proposals as the environmental impact of these projects may not aggravate / worsen the critical pollution of Angul - Talcher area, which is mainly air and water pollution.



c) The SEAC opined that there is no Circular or Office Memorandum issued by the MoEF&CC, Govt. of India about non-applicability of general conditions for the Critically Polluted Areas if the unit is having only air and water pollution potential.

After detailed discussion, the SEAC reiterates its earlier recommendations and decided to return these 04 applications to SEIAA, Odisha with a request to request MoEF&CC, Govt. of India to advise with Circular or Office Memorandum of MoEF&CC, Govt. of India if any that general condition is not applicable for the projects located within the Critically Polluted Area or within 05 km from boundary of Critically Polluted Area where Moratorium period for such Critically Polluted Area has been lifted.

(III) DE-LISTING OF COUNTRY LIQUOR PROPOSALS WHICH HAVE NOT FURNISHED THE COMPLIANCE TO THE QUERIES RAISED BY THE SEAC, ODISHA AFTER MORE THAN SIX MONTHS.

The SEAC, Odisha decided to return 12 nos. of proposals (as per **Annexure-III**) to SEIAA, Odisha with a request to delist the same as they have not complied to the queries after more than six months of time period.


