

As per the guidelines of the SEIAA for construction projects involving violation, the rationalized project cost for total built up area 37,359.0 Sq.m. is Rs. 37,35,90,000/- and the amount of Bank Guarantee is Rs. 37,36,000/- for Implementation of Remediation plan; Natural Resource Augmentation Plan; and Community Resource Augmentation Plan. Hence, the proponent shall submit Bank Guarantee for an amount of Rs. 37,36,000/- (Rupees Thirty Seven Lakhs Thirty Six Thousand only) along with detailed action plan for implementation.



The SEIAA discussed the recommendations of the SEAC in detail and noted that the project obtained EC dt.10.06.2013 with validity for 20 years for mining 500 m³/annum of colour granite and exceeded the production capacity without obtaining prior EC for expansion. They applied for EC for expansion under violation category as per OM dt.09.09.2018 with proposal no. **SIA/TG/MIN/73779/2018** and it was directed to apply for TORs under violation. The proponent is proposed for enhancement of production capacity of the project from 500 m³/annum to 18000 m³/annum of Colour granite. The proposal is considered under Violation and processed as per S.O. 804(E) dt. 14.03.2017, S.O. 1030 (E) dt. 08.03.2018, OM dt. 12.11.2020 & Lr. dt. 16.02.2021 issued by the MoEF&CC, GoI. Hence, approved for TORs under violation category with a condition that the proponent shall immediately restrict the production to the 500 m³/annum as permitted EC dt.10.06.2013 and shall submit the compliance report duly certified by ADMG along with EIA report.



The SEIAA discussed the recommendations of the SEAC in detail and noted that the project obtained EC dt.29.11.2012 with validity for 17 years for mining 900 m³/annum of colour granite and exceeded the production capacity without obtaining prior EC for expansion. They applied for EC for expansion under violation category as per OM dt.09.09.2018 with proposal no. **SIA/TG/MIN/73798/2018**. The proponent is proposed for enhancement of production capacity of the project from 900 m³/annum to 18000 m³/annum of Colour granite. It was noted from the latest google map that the nearest human habitation i.e., Sarvareddypalli (V) is at a distance of about 180 mtrs. and not meeting the siting guidelines for mining activity, hence rejected.

However, the concerned authority shall initiate credible action against the project for violation under E(P) Act. and other relevant Acts.
