Nodal Officer, SEIAA-UP informed that in light of minutes of the meeting of joint meeting of SEIAA, SEAC-1 & SEAC-2 held on 22.06.2021, minutes of the 585th, 589th, 590th and 594th meeting of SEAC-2 have been vetted by SEAC-1.

SEIAA noted that the above project was taken in its 486th meeting dated 02.09.2021 in which SEIAA found that in mining plan approval letter it is mentioned that the depth of mining shall be upto 3 meters or water level whichever is earlier, whereas ultimate depth of mining in mining plan is mentioned as 30 meters. Clarification from DGM has been received. After reviewing the reply, SEIAA agreed with the recommendations of the SEAC to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC but the SEIAA replaces the specific condition

regarding cluster certificate as “If in future during the progressive mining this lease area becomes part of cluster i.e. area equal to or more than 5 ha., limited to B-1 category, then additional conditions based on the EIA conducted by the concerned lease holders shall be imposed and joint EMP shall be implemented. The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. If the certificate related to cluster provided by the competent authority is found false or incorrect then punitive actions as per the law shall be initiated against the authority issuing the cluster certificate” and adding following conditions:-
