A. CONSIDERATION OF COUNTRY LIQUOR PROPOSALS :

The committee verified the application furnished in Form-I along with documents and checklist of 08 nos. of country liquor proposals. Out of 8 nos. of country liquor proposals, 02 nos. of country liquor proposals for appraisal at SEAC, Odisha for change of location of Main Out Still Liquor Shop and 06 nos. of country liquor proposals for appraisal at SEAC, Odisha for Revalidation of EC of Main Out Still Liquor Shop.

After detailed discussion, the SEAC decided to take decision on these 08 nos. of country liquor proposals (list as per **Annexure-I**) after receipt of previous old files of the respective proposals from SEIAA, Odisha.


B. CONSIDERATION OF MINOR MINERAL PROPOSALS:


1. The SEAC in its meeting held on 15.04.2019 had recommended the following:
 - a) The SEIAA, Odisha may consider to seek advice of MoEF&CC, Govt. of India about processing and appraisal of minor mineral proposals in view of order of the Hon'ble NGT, New Delhi dated 13th September, 2018 and whether amendment of EIA Notification will be required for the purpose.
 - b) The proposals of minor minerals pending with the SEAC will be returned to SEIAA, Odisha till these proposals are submitted with District Survey Report and a clarification received from MoEF&CC, Govt. of India as per the orders of Hon'ble NGT.


2. The SEAC verified from the online system (in second phase), there are 4 minor mineral proposals are pending at the proponent end due to want of information.

After detailed discussion, the SEAC decided to return these 04 nos. of minor mineral proposals (**as per Annexure - II**) to SEIAA, Odisha for further action as per the above decision of the SEAC. The SEAC also recommended to delist 04 nos. of proposals as per MoEF&CC, Govt. of India OM No.J-11013/5/2009-IA-II (Part) dated 30th October, 2012.
