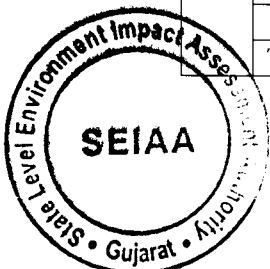


Minutes of the 848th Pat-II Meeting held on 19th July 2022

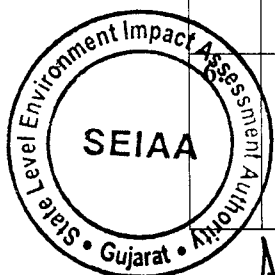
