SEIAA noted that SEAC-2 has recommended to issue ToR in its meeting dated 29.07.2021. In light of decision taken in the Joint meeting of SEIAA, SEAC-1 and SEAC-2 held on 15.07.2021, SEAC-1 vetted the said project in its meeting dated 31.07.2021. SEIAA gone through file, documents and office memorandum no. 329/77-3-20-158(M)/2018 dated 19.03.2020 of Industrial Development Department, UP mentioning 6-nodes for Defence Industrial Corridor as Aligarh, Agra, Jhansi, Chitrakoot, Kanpur and Lucknow. SEIAA agreed with the recommendation of the SEAC to issue ToR adding the following points to ToR:-

- In case Chrome plating industry are to be established mitigation measures should be imposed.
- A proposal for preparing annual sustainability report should be included in EIA/EMP.
- Proposal to establish Primary Health Centre should be included in the project and proposed in EIA.
- Environment management cell headed by a qualified Environment Health and safety (EHS) expert shall be proposed in EIA.
- All pages of technical documents/EIA/EMP etc. should be signed by the consultant and project proponent both.
- 6. Public hearing shall be conducted as per EIA notification, 2006 (as amended).
- In case of brown field project environmental footprint of the site and mitigation measures should be included in EIA-EMP report.
- Observation raised in public hearing and replies submitted by project proponent proposed action plan leading to modification should be included in EIA-EMP report.
