At the same time it has also decided that to incorporate additional conditions to the above mentioned project proposals as suggested by Chairman, SEAC on 30.10.2019 and communicated via official e-mail dated 30.10.2019 at 12:30 PMas the following:-.

"In all Stone Mining projects, depending upon the air pollution estimates based upon fuel use in operations and activities of the respective projects; required monitoring station based air quality monitoring shall be done in the influence area of the project with needed mitigation conditions to ensure sustainable Stone mining as per guidelines, circulars and norms of MOEFCC / Hon'ble NGT or any other directives of regulatory / statutory bodies and competent Courts.

PP to take preventive steps to avoid flash flood conditions arising from mining operations and probable run off in rainy season conditions.

The Authority considered the recommendation made by SEAC for grant of Environmental Clearance in the light of memo no. 769/M, dated 12.10.19 of District Mining Officer, Garhwa and an application dated 29.10.19 of project proponent.

District Mining Officer, Garhwa vide his letter dated 12.10.19 has informed the applicants that as per 9 (1) Soof Jharkhand Minor Minerals (Amendment) Rules, 2017, due to non submission of Environmental Clearance within 180 days from the date of issue of LOI, the applicants application with regard to LOI has been automatically come to an end.

The project proponent vide his application dated 29.10.19 prayed that the information forwarded by District Mining Officer, Garhwa vide his letter dated 12.10.19 has false on the matter of LOI issued to the favour of above project. Further, project proponent has requested that SEIAA, Jharkhand may seek clarification from additional Collector, Garhwa regarding the current status of LOI before taking final decision in the matter of Environmental Clearance.

Further during perusal of records available in file following anomalies have been found which is being given below:

Hence after full deliberations it was unanimously decided that before taking final decision on this case a clarification should be sought from Deputy Commissioner, Garhwa on the issue raised by the District Mining Officer, Garhwa vide his memo no. 769/M, dated 12.10.19 and clarify whether the project proponent of above project is a legal/bonafideapplicant or not. At the same time it was also decided that the Deputy Commissioner, Garhwa may clarify the above anomalies found in the different letters issued by District Mining Officer, Garhwa.
