

**MINUTES OF THE 86<sup>th</sup> GOA STATE ENVIRONMENT IMPACT ASSESSMENT  
AUTHORITY (GOA-SEIAA) MEETING HELD ON 12/09/2022 AT 03.30 P.M. IN  
THE CONFERENCE ROOM OF THE 4<sup>th</sup> FLOOR, DEMPO TOWER, PATTO,  
PANAJI-GOA.**

The Eighty sixth meeting of the Goa - SEIAA (*hereinafter referred as 'Authority'*) was held on 12<sup>th</sup> September 2022 at 03.30 pm in the conference room, 4<sup>th</sup> floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (*refer Annexure - 1*).

At the outset, Chairman welcomed Authority members and briefed about the agenda items (*refer Annexure -2*) to be taken up for discussion / deliberations and suitable decision. Accordingly, the same were considered as detailed below.

**1. To decide on application received from M/s MRF Ltd. locating at Survey No. 258/0, 259/1 and 259/2-A, Tisk Usgao, Ponda Goa for prior EC.**

**Background:** As per the direction of the Chairman Goa-SEIAA, the inspection of MRF Ltd was carried out by the Engineer, of SEIAA on 25/08/2022 at 11:00 a.m.

**Decision:** After scrutinizing the site inspection report and the photographic evidence submitted by SEIAA Engineer, the Authority instructed the SEIAA Engineer to submit more detailed site inspection report.

**2. To decide on application received for expansion of Environment Clearance from Priyadarshani Hi Tech Associates basalt stone quarry at Vantem bearing Survey No. 119(Part) Vantem, Sattari Goa.**

The consultant Shri. Vishal Sannakki of Priyadarshani Hi Tech Associates basalt stone quarry appeared before the Authority and informed the Authority that the PP is not able to attend the meeting due to unavoidable circumstances.

**Decision:** The Authority decided to defer the matter to the next meeting as the PP was not available. The Authority noted that the PP is yet to deposit the amount of fine (Letter No.68/3/2022-23/GSEIAA/Project-Prop/111 dated 28/07/2022) for non submission of six monthly compliance reports.

**3. To decide on application received from Rajendra Naik bearing Survey No. 17/1, Antorem village, Sanguem Goa for prior EC.**

The Project Proponent Shri. Rajendra Naik along with his adviser Mr. B.G. Joshi appeared before the Authority.

**Decision:** After scrutinizing the documents submitted by the PP, the Authority noticed that there is another existing quarry within the vicinity of 300 meters from the proposed site. Therefore this may form a cluster. As such proposal shall be

treated as B2 par with B1 category as per the Office Memorandum issued by MoEF&CC dated 12/12/2018.

Hence, the application for prior Environmental Clearance stands rejected.

**4. To decide on application received for extension of validity of Environment Clearance from Zuari Industries, bearing Survey No. 288(Part), 289(Part) and 294(Part) located at Loutolim, Salcete South Goa.**

The representative of Zuari Industries Shri. Prashant Nayak along with the consultant Shri. Vishal Sannakki appeared before the Authority and explained the details of the project.

**Decision:** After scrutinizing the application and documents submitted by the PP, the Authority suggested the PP to comply with the following:


- i. To asphalt all internal roads, within lease area to minimize dust and sound pollution.
- ii. To submit the details of the trees to be planted.
- iii. To submit the list of activities to be carried out under CER.


**5. Any other matter with permission of the chair.**

**i. Audit Report for the period FY2021-22 received from Rao & Emmar Chartered Accountant.**

**Decision:** After scrutinizing the report from Chartered Accountant, the Authority decided to approve the Audit of the financial statements and general accounting of the Goa State Environment Impact Assessment Authority for the period FY2021-22.
