The proposal of SEAC dated 04.12.2023 recommending the approval of Terms of Reference was discussed.

After detailed deliberation, TOR is approved incorporating all the conditions stipulated by SEAC and with conduct the public hearing, and PP shall submit all the details/data in revised format along with segregation of waste water stream, reduction/increase waste water if any applicable.

The proposal of SEAC dated 04.12.2023 recommending the grant of Environment Clearance was discussed.

Authority reviewed SEAC recommendation, where, submitted Government notification (Ta. Mandal, Vill. Vithalpur) is of Revenue department, published under land accumulation Act. However, proponent has not submitted GIDC notification for notifying of Mandal Industrial estate.

After detailed deliberation, Environment Clearance is Deferred to SEAC for the verification of following points:

- 1. Looking to the GIDC Notification of Mandal Industrial Estate, it appears that it is Mandal (Japanese industrial zone), Phase-I, (tentative). Therefore, it may be clarified from GIDC, whether, it is limited to Japanese units only and only for tentative purpose, in that case, whether, benefits of notified GIDC estates, will be applicable to the applicant for the purpose of exemption from Public hearing.
- 2. Also, examine, Gujarat Special investment Region dated 24.9.2012 of industrial and mines department may be examining, whether Mandal Industrial Estate is covered or not.

Alchemie Finechem Private Limited (new name) but in parivesh portal the name of old project is i.e. M/s. Alchemie Laboratories is not mentioned in "details of Earlier project proponent".

Comitee noted that in pativesh portal, earlier Project proponent and new Project proponent in both details, where name is same i.e to M/s. Alchemie Finechem Private Limited which is not acceptable.
