MINUTES OF THE 94TH GOA STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (GOA-SEIAA) MEETING HELD ON 03/01/2023 AT 03:30 P.M. IN THE CONFERENCE ROOM OF THE 4th FLOOR, DEMPO TOWER, PATTO, PANAJI-GOA.

The 94th meeting of the Goa - SEIAA (hereinafter referred as 'Authority') was held on 03^{rd} January 2023 at 03:30 pm in the conference room, 4th floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (<u>refer Annexure</u> – 1).

At the outset, Chairman welcomed Authority members and briefed about the agenda items (*refer Annexure* –2) to be taken up for discussion / deliberations and suitable decision. Accordingly, the same were considered as detailed below.

1. To decide on application received for extension of validity of Environment Clearance from Rajendra Naik Vazangall Shiroda Laterite Quarry at Survey No. 839/1, Shiroda, Ponda - Goa.

The Project Proponent Shri. Rajendra Naik appeared before the Authority and explained the details of the project.

Deliberation: After scrutinizing the application submitted by the Project Proponent and recommendation given by Goa - SEAC, the Authority decided to grant the extension of validity of Environmental Clearance for a period of 2 years i.e upto 08/05/2025 with subject to the specific conditions and general condition stating that any guidelines issued by MoEF&CC by way of Notifications/Office Memorandums if any issued during the validity period of this EC then the said Notifications/Office Memorandums will be made applicable from the date of issuance of the said Notifications/Office Memorandums.

Decision: The Authority decided to grant extension of Environmental Clearance upto 8th May 2025 and further the Authority directed the Project Proponent to submit the details of activities to be undertaken under CER.

2. To decide on application received from M/s Delanco Home & Resorts Private Limited for transfer of Environment Clearance to DLF Exclusive Floors Private Limited located at Survey No. 87/1-A-1 and 87/1-A-2 of Reis Magos village, Bardez taluka Goa.

Shri. Krishna Parab (Manager) who claimed to be representative of M/s DLF Exclusive Floors Pvt. Ltd. along with his consultant Poonam Morya appeared before the Authority and explained the details of the project.
