**Note: Submit a copy of each of above documents - Hard and Soft Copies (CD) to the Member secretary, Violation (Note: Not by Name) by speed post so as to reach well in time.**

- Compliance Report from Regional Office, MoEF&CC (Applicable for projects already having EC).
- The KML/Shape files should be emailed to mentioned at para No. 7 below at least 5 days prior to the meeting.***
- The above all documents are required to be forwarded to the Chairman/Members of the Expert Appraisal Committee along with soft copy.

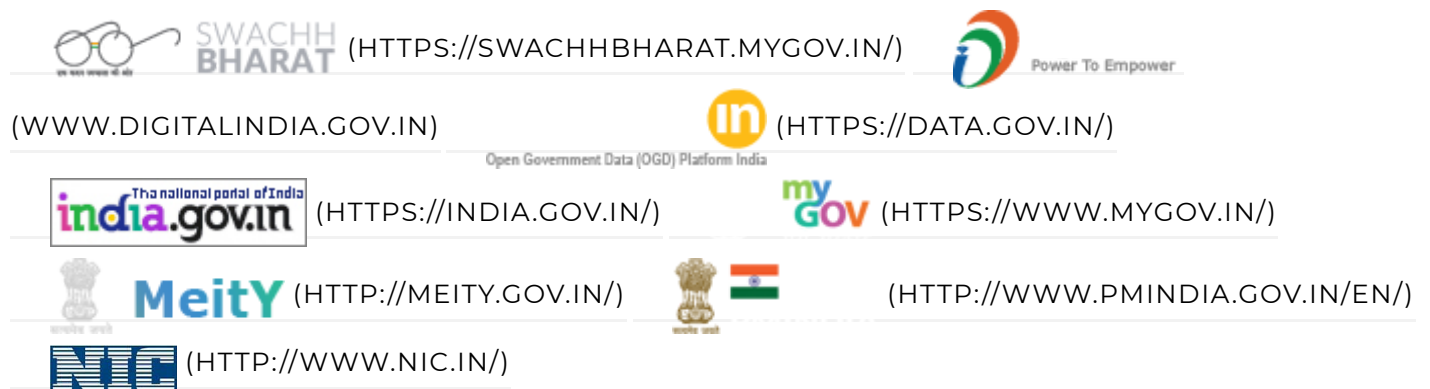
