In view of the consideration of SEAC and its recommendation to grant of Environmental Clearance (EC), the SEIAA resolved to grant EC with standard conditions in addition to special conditions i.e. provide solar panels in 30% of total rooftop area (open terrace), plantation along the road by increasing green belt, undertake Corporate Environmental Responsibility (CER) proposal, in consultation with the concerned authority of the Local Body (Municipal Corporation/Municipality/Nagar Panchayat/Gram Panchayat), the activities shall predominantly include Municipal Solid Waste Management activities like:- Material Recovery Facilities, Waste processing Facilities, Waste collection vehicles, make provisions for sufficient number of electric vehicle charging points at parking area, both fir four wheelers and two wheelers. The visitors parking and Flat Owners parking space

should be separated, the Green patch must be 15% of total plot area, the approach road to the Apartment is not as per the movement of vehicles for the residents besides a big drain, so proper approach road approval may be obtained, the management plans of STP, roads, basic amenities, solid waste management, first aid-medical facilities, emergency telephone numbers etc. are essentially needed, along with special conditions as imposed by the SEAC in its MoM (Ref. No. 317, dated 11.07.2022).
